Michael Kovac is the Chief of the Prosecutions Division for the Nevada Attorney General's Office. In that capacity, he directly prosecutes and supervises the Deputy Attorney Generals throughout the state of Nevada. Not only does he work tirelessly to prosecute cases, but he aided in strengthening criminal justice laws in Nevada and guides Attorney General Aaron D. Ford in his efforts to implement criminal justice reforms.

Kovac is considered an expert in Constitutional Law and teaches the subject for the USC Gould School of Law's online programs. Kovac has worked in numerous additional positions in or related to the legal profession. Specifically, he has worked as a law clerk for the Court of Appeals for the Second Judicial District Court of the United States, the Allegheny County (Pennsylvania) Court of Common Pleas' Commerce and Complex Civil Litigation Center, and the Las Vegas Township Justice Court. Prior to completing law school, he worked as a paralegal specialist for the United States Attorney's Office for the Western District of Pennsylvania and as a probation officer.

Kovac is a member of the state bars for the states of Nevada, California, and Pennsylvania. He previously taught Law and Society for Nevada State College. Kovac received his law degree from Duquesne University School of Law, where he graduated in top ten percent of his class and was a member of the Duquesne Law Review. He received his undergraduate degree (majoring in education) from the University of Pittsburgh (Johnstown).

I am recommending him for this award because his leadership has resulted in many successful prosecutions throughout the state and he has been instrumental in promoting participation in local and statewide multidisciplinary teams to combat crimes such crimes as human trafficking, money laundering and abuse against vulnerable Nevadans. Not only is he an asset to Nevada, but Kovac also coordinates conferences to promote the rule of law beyond the United States.
