AN ACT to provide for the application by the State of New Jersey
to the Congress of the United States for the calling of a conven-
tion for proposing an amendment to the Constitution of the
United States.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. The State of New Jersey hereby applies to the Congress of
2 the United States of America under Article V of the United States
3 Constitution to call a convention for proposing an amendment to
4 the United States Constitution to do the following:

5 a. With respect to the right to life guaranteed in the United
6 States Constitution, provide that every human being subject to the
7 jurisdiction of the United States or any state shall be deemed
8 from the moment of fertilization to be a person and entitled to the
9 right to life.

10 b. Provide that Congress and the several states shall have con-
11 current powers to enforce such an amendment by appropriate
12 legislation.

13 The purpose of the Constitutional Convention shall be to only
14 consider the above and no other business.

1 2. Copies of this act shall be sent to the legislatures of all the
2 states, to the Clerk of the United States House of Representatives
3 and to the Secretary of the Senate in Washington, D.C., requesting
4 the several states to also pass an identical application to the United
5 States Congress so as to meet the Constitutional requirements for
6 application for such a convention by two-thirds of the states.

1 3. This act shall take effect immediately.
