SENATE JOINT RESOLUTION

1
2 rescinding certain applications made by the Texas Legislature to
3 the United States Congress to call a national convention under
4 Article V of the United States Constitution for proposing any
5 amendment to that Constitution.

6 WHEREAS, Over the years, the Texas Legislature has approved
7 resolutions officially applying to the Congress of the United
8 States to call a convention, under the terms of Article V of the
9 Constitution of the United States, to offer various amendments to
10 that Constitution; and

11 WHEREAS, While no Article V amendatory convention has yet
12 taken place thus far in American history, nevertheless, there is a
13 very real possibility that one, or more than one, could be triggered
14 at some point in the future; and

15 WHEREAS, Regardless of their age, such past applications from
16 Texas lawmakers remain alive and valid until such time as they are
17 later formally rescinded; now, therefore, be it

18 RESOLVED, That the 85th Legislature of the State of Texas,
19 Regular Session, 2017, hereby officially rescinds, repeals,
20 revokes, cancels, voids, and nullifies any and all applications
21 from Texas legislators prior to the 85th Legislature, Regular
22 Session, 2017, other than the application provided by H.C.R.
23 No. 31, Acts of the 65th Legislature, Regular Session, 1977, that
24 apply to the United States Congress for the calling of a convention,

1 pursuant to Article V of the United States Constitution, regardless
2 of how old such previous applications might be, and irrespective of
3 what subject matters such applications pertained to; and, be it
4 further

5 RESOLVED, That the 85th Legislature of the State of Texas,
6 Regular Session, 2017, hereby declares that any application to the
7 United States Congress for the calling of a convention under
8 Article V of the United States Constitution that is submitted by the
9 Texas Legislature during or after this Regular Session shall be
10 automatically rescinded, repealed, revoked, canceled, voided, and
11 nullified if the applicable convention is not called on or before
12 the eighth anniversary of the date the last legislative vote is
13 taken on the application; and, be it further

14 RESOLVED, That, in a manner which would furnish confirmation
15 of delivery and tracking while en route, the Texas secretary of
16 state shall transmit properly certified copies of this joint
17 resolution of rescission, pursuant to the Standing Rules of the
18 United States Senate (namely, Rule VII, paragraphs 4, 5, and 6), to
19 the vice president of the United States (in his capacity as
20 presiding officer of the United States Senate and addressed to him
21 at the office which he maintains inside the United States Capitol
22 Building); to the secretary and parliamentarian of the United
23 States Senate; and to both United States senators representing
24 Texas; accompanied by a cover letter to each addressee drawing
25 attention to the fact that it is the 85th Texas Legislature's
26 courteous, yet firm, request that the full and complete verbatim
27 text of this joint resolution be duly published in the United States


1 Senate's portion of the *Congressional Record* as an official
2 memorial to the United States Senate, and that this joint
3 resolution be referred to whichever committee or committees of the
4 United States Senate that would have appropriate jurisdiction in
5 this matter; and, be it further

6 RESOLVED, That, in a manner which would furnish confirmation
7 of delivery and tracking while en route, the Texas secretary of
8 state shall likewise transmit properly certified copies of this
9 joint resolution of rescission, pursuant to the Rules of the United
10 States House of Representatives (namely, Rule XII, clauses 3 and
11 7), to the speaker, clerk, and parliamentarian of the United States
12 House of Representatives; and to all members of the United States
13 House of Representatives who represent districts in Texas; likewise
14 accompanied by a cover letter to each addressee drawing attention
15 to the fact that it is the 85th Texas Legislature's courteous, yet
16 firm, request that the substance of this joint resolution be
17 accurately summarized in the United States House of
18 Representatives' portion of the *Congressional Record* as an official
19 memorial to the United States House of Representatives, and that
20 this joint resolution be referred to whichever committee or
21 committees of the United States House of Representatives that would
22 have appropriate jurisdiction in this matter.


