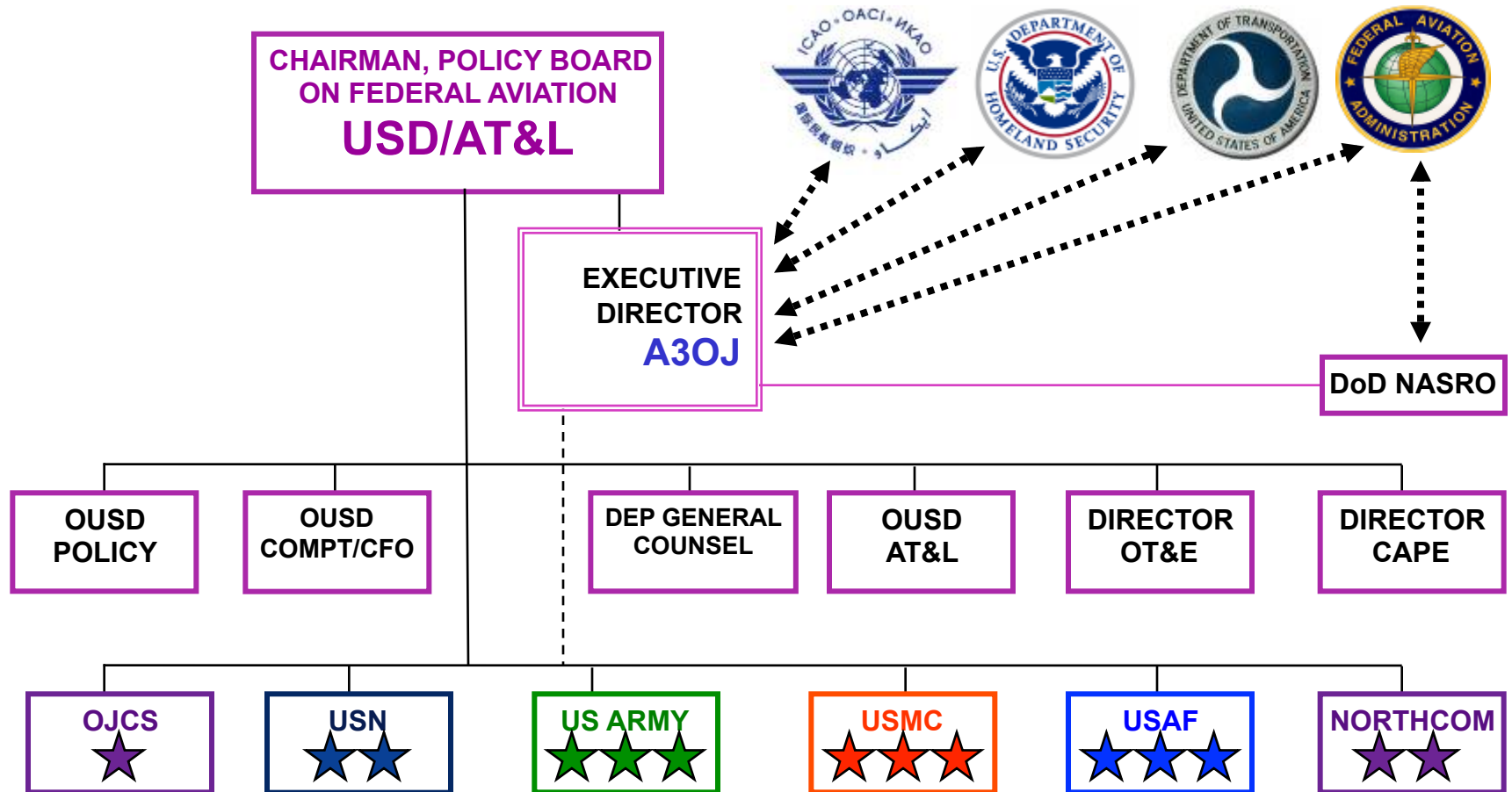

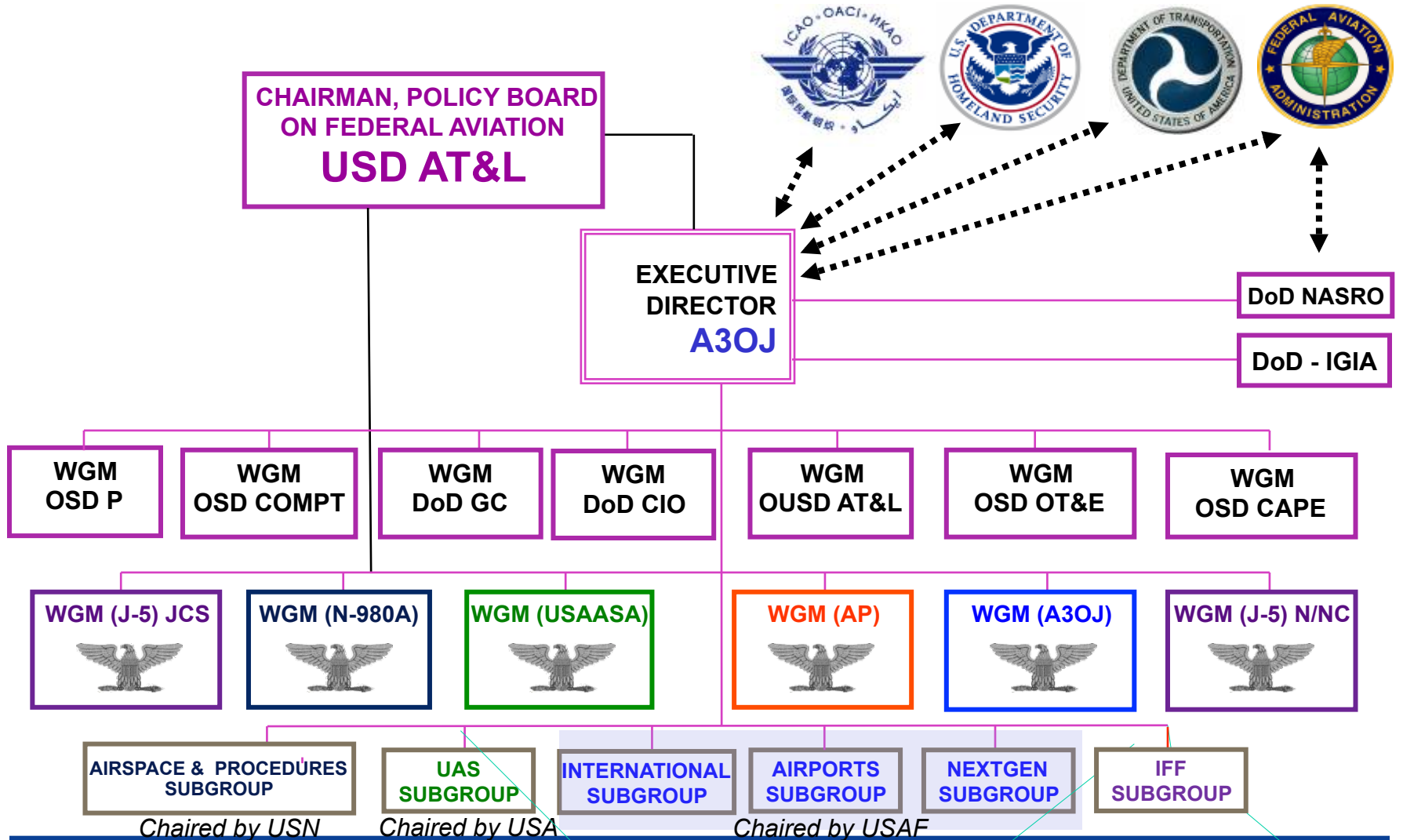


DoD Policy Board on Federal Aviation (PBFA) Executive Structure

DoD Equity across the NAS

- **DoD impacted by FAA NAS modernization across aircraft, airport and ATC systems...over 15,000 aircraft**
 - **Priorities are communicated thru numerous means...PBFA, LSO, FACA, ARC, NG Exec Board, Exec Comm**
 - **FAA modernization adds to combat requirements driving up aircraft costs over commercial costs**

- **Unique National Defense NAS procedures, programs and policy**
 - **Rely on some FAA capabilities to provide National Defense...integrated surveillance, ATCSCC**
 - **Coordination between FAA/DoD on NAS defense missions...ESCAT, NOBLE EAGLE, VIP/SAAM**
 - **Numerous Joint Orders, COAs, MOAs/MOUs, LOAs at National, Regional and Local level**

- **DoD provides 20% Air Navigation Service Provider (ANSP) capability to all users of the NAS...GPS, radars, NAVAIDS, ATC controllers...DoD ANSP capability also provides readiness training for ATC combat mission**

- **DoD requires access to NAS and airspace (Military Operating Areas, Warning Areas, Restricted Areas, ...) to train our warfighters, test new concepts and defend the Nation...manage 16% of NAS airspace, large force exer, UAS**

- **FAA together with DoD coordinate/represent USG positions at ICAO and international engagements**

- **FAA/DoD high priorities set thru Executive Orders, NDAA, FAA Reauth & Reform Act,...**

- **Need to fully understand DoD and FAA links to continue National Defense priorities that currently exist**

- **Governance requires DoD representation to help understand defense perspective**

- **Requires USAF, USN, USA and OSD representation on Board of Directors**
