#### **GENERAL INSTRUCTIONS AND DEFINITIONS**

Draft data submissions for licensure compliance reporting are detailed in this document, along with reporting timelines and definitions. Annual licensure renewal will require the timely receipt of all data described herein from the time of the previous annual renewal date. Institutions that report enrollment, degrees, and transfer data to the Council through its unit record data collection system are exempt from the reporting requirements detailed in this document. By the time of first collection, the Council will provide a Web-based data collection system to decrease the reporting burden on institutions.

The Council's data reporting requirements may change on an annual basis in response to changes in state and federal reporting mandates. All changes in data fields and definitions will be finalized, with written notice posted to the Council's Web site, at least six months prior to the due date for the form in question.

Out-of-state institutions must complete one set of forms for each instructional site for which they are licensed. An out-of-state institution that is operating or soliciting using online instruction to Kentucky residents shall be considered to have an online campus which shall be licensed and reported separately as an instructional site. Out-of-state institutions, including those with exclusively online delivery in Kentucky, should only report students who were Kentucky residents at the time of first admission.

#### REPORTING DEADLINES

Licensure compliance reports will be due to the Council annually at two points during the year.



Forms A- E summarize enrollment in the fall semester only, and should include enrollment in all courses (day, evening, off-campus, online, and telecourse) for which semester hour credit is granted. The data are to be the net enrollment as of the last day of the reporting period on which students may add a course for credit (cut-off date). This date must agree with the official college calendar. All enrollment transactions initiated on or before the cut-off date should be processed and reflected in the report. Exclude students who have withdrawn on or before the

cut-off date, have not paid, or have not made arrangements with the business office for payment of tuition and fees.

Do not include enrollment in correspondence courses, noncredit courses, noncredit workshops, continuing education unit courses, or other courses for which regular semester hour credit is not granted. Do not include enrollment in classes which did not materialize, were cancelled, or otherwise not in fact offered. Do not include enrollment from previous semesters.

Institutions without traditional fall semesters should report for the same period of enrollment reported to IPEDS on the fall enrollment collection.

#### TRANSFER AND DEGREES CONFERRED FORMS

Forms F and G summarize transfer activity and degrees and credentials awarded during the previous academic year. Form F should reflect all first-time students transferring to your institution or continuing students transferring in credit from other institutions. Form G should reflect degrees awarded by the close of the academic period between July 1 and June 30. Do not report any degrees or awards conferred in previous academic years or not yet completed based on institutional academic policy.

#### **DEFINITIONS**

<u>Audit Course</u> - A credit course will be defined as "audit" for a student who takes the course for zero hours credit.

<u>Audit Student</u> - Student who is not enrolled in a degree program, but enrolled only in one or more "audit course."

<u>Declared Major</u> - The major program and degree level objective, according to the student's stated intent.

<u>Doctor's Degree – Research/Scholarship</u> – A Ph.D. or other doctor's degree that requires advanced work beyond the master's level including the preparation and defense of a dissertation based on original research, or the planning and execution of an original project demonstrating substantial artistic or scholarly achievement. Some examples of this type of degree may include Ed.D., D.M.A., D.B.A., D.Sc., D.A., or D.M., and others, as designated by the awarding institution.

<u>Doctor's Degree – Research/Scholarship Course-taking Student</u> - Doctoral student who is taking coursework and is not yet working exclusively on a research project or dissertation.

<u>Doctor's Degree – Research/Scholarship Dissertation Student</u> - Doctoral student who has completed all required coursework and is working on a research project or dissertation.

<u>Doctor's Degree – Professional Practice</u> – A doctor's degree that is conferred upon completion of a program providing the knowledge and skills for the recognition, credential, or license required for professional practice. The degree is awarded after a period of study such that the total time to the degree, including both pre-professional and professional preparation, equals at least six full-time equivalent academic years. Some of these degrees were formerly classified as "first-professional" and may include: Chiropractic (D.C. or D.C.M.); Dentistry (D.D.S. or D.M.D.); Law (L.L.B. or J.D.); Medicine (M.D.); Optometry (O.D.); Osteopathic Medicine (D.O.); Pharmacy (Pharm. D.); Podiatry (D.P.M., Pod.D., D.P.); or Veterinary Medicine (D.V.M.), and others as designated by the awarding institution.

<u>First-Time Student</u>- Student who has not previously attended any college or university or who attended college level courses as a high school student and is currently enrolled for the first time since high school graduation. Does not include students who are currently in high school taking collegiate level courses.

<u>First-Time Transfer Student</u> - A certificate-, diploma-, or degree-seeking student entering the reporting institution for the first time but known to have previously attended a postsecondary institution at the same level (e.g., technical, undergraduate). The student may transfer with or

without credit at the time of entry.

<u>Full-Time Student</u> - An undergraduate student enrolled for the number of hours required by the institution for full-time status.

<u>Graduate Nondegree Student</u> - Student with a baccalaureate degree enrolled in the graduate school but not in a degree program, enrolled in courses for credit, or a student working toward "rank one" certification.

<u>High School Student</u> - Student currently in high school and enrolled in collegiate level courses; should be reported with nondegree major code (90.0000).

<u>Kentucky County, State, Territory, or Foreign Country of Origin</u> - County, state, territory, or country of legal residence at time of first admission to the institution.

<u>Lower Division Student</u> - Undergraduate student who has earned less than 50 percent of the number of academic credits normally required for a baccalaureate degree. These students are to be classified as freshmen and sophomores.

<u>Master's Degree Student</u> - Student with at least a baccalaureate degree enrolled in a graduate program which results in a master's degree.

<u>Net Credit Hour Enrollment</u> - Total credit hours for which a student is enrolled as of the cut-off date.

Net Headcount Enrollment - Total number of students who are enrolled as of the cut-off date.

<u>Not Designated/Undecided/Undeclared</u> - The major field for a degree-seeking student who has not (by his choice or by institutional limitations) declared a major.

<u>Post-Baccalaureate Certificate Student</u> – A student enrolled in a CPE-approved post-baccalaureate certificate program.

<u>Post-Baccalaureate Degree-Seeking Student</u> – A student with a baccalaureate degree who is working toward another baccalaureate degree or an associate degree.

<u>Post-Baccalaureate Nondegree Student</u> - Student with a baccalaureate degree who is enrolled in undergraduate coursework but is not enrolled in an undergraduate degree program. Should be reported with nondegree major code (90.0000).

<u>Post-Master's Certificate Student</u> – A student enrolled in a CPE-approved post-master's certificate program.

Race/Ethnicity -- Categories developed in 1997 by the US Office of Management and Budget (OMB) that are used to describe groups to which individuals belong, identify with, or belong in the eyes of the community. The categories do not denote scientific definitions of anthropological origins. The results are to be reported to CPE using the same summary format required by IPEDS beginning in 2010/2011:

Nonresident Alien -- A person who is not a citizen or national of the United States and who is in this country on a visa or temporary basis and does not have the right to remain indefinitely. Note: Nonresident aliens are to be reported separately in the places provided, rather than in any of the racial/ethnic categories described below. A person who is not a citizen or national of the United States but who has been admitted as a legal immigrant for the purpose of obtaining permanent resident alien status (and who holds either an alien registration card (Form I-551 or I-151), a Temporary Resident Card (Form I-688), or an Arrival-Departure Record (Form I-94) with a notation that conveys legal immigrant status such as Section 207 Refugee, Section 208 Asylee, Conditional Entrant Parolee or Cuban-Haitian) is to be reported in the appropriate racial/ethnic categories along with United States citizens.

<u>Race and Ethnicity unknown</u> -- The category used to report students whose race and ethnicity are not known.

<u>Hispanics of any race</u> -- A person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin, regardless of race. Individuals who designate their ethnicity as Hispanic or Latino and also select one or more races are to be reported in this category regardless of any other race or races selected.

#### For non-Hispanics only:

American Indian or Alaskan Native only -- A person having origins in any of the original peoples of North and South America (including Central America) who maintains cultural identification through tribal affiliation or community attachment. Only report an individual in this category if she or he is non-Hispanic and did not select any other races.

Asian only -- A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian Subcontinent, including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam. Only report an individual in this category if she or he is non-Hispanic and did not select any other races.

<u>Black or African American only</u> -- A person having origins in any of the black racial groups of Africa. Only report an individual in this category if she or he is non-Hispanic and did not select any other races.

<u>Native Hawaiian or Other Pacific Islander only</u> -- A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands. Only report an individual in this category if she or he is non-Hispanic and did not select any other races.

<u>White only</u> -- A person having origins in any of the original peoples of Europe, the Middle East, or North Africa. Only report an individual in this category if she or he is non-Hispanic and did not select any other races.

<u>Two or more races</u> – Report all non-Hispanic/Latino individuals who select two or more races in this category.

<u>Specialist's Degree Student</u> - Student with at least a master's degree enrolled in a graduate program which results in a specialist's degree.

<u>Technical/Semi-Professional</u> - Associate and certificate level student credit hours except declared majors with CIP disciplines of 24, 30, 90, or 00. Student credit hours in these disciplines should be included in lower division.

<u>Transient Student</u> - A student in good standing in any recognized institution who is taking work in another institution to transfer back to the first institution.

<u>Undergraduate Nondegree Student</u> - Student who is enrolled for credit in undergraduate courses but does not intend to receive a degree from the institution and has not received an undergraduate degree. Does not include students who are currently in high school taking collegiate level courses.

<u>Upper Division Student</u> - Undergraduate student who has earned at least 50 percent of the number of academic credits normally required for a baccalaureate degree. These students are to be classified as juniors, seniors, or post-baccalaureate.

#### FORMS A-1 AND A-2 - INSTRUCTIONS

#### FALL HEADCOUNT ENROLLMENT

<u>Forms A-1 and A-2</u> - Report undergraduate degree-seeking students on lines A through E, G, and H, and graduate degree-seeking students on lines M through R. Report undergraduate nondegree-seeking students on line I, and graduate nondegree-seeking students on line S.

An undergraduate student is to be classified based on total semester credit hours earned, except in the following cases:

- (a) A high school student enrolled in an early admissions program for academic credit should be classified as "high school student."
- (b) A transient student is to be classified as "undergraduate nondegree" or "graduate nondegree," depending upon degree level.
- (c) "Undergraduate nondegree," "graduate nondegree," "audit," "post-baccalaureate nondegree," "post-baccalaureate certificate," and "post-baccalaureate degree-seeking" students.

<u>Form A-1 Total Headcount Enrollment</u> - Classify total headcount enrollment by full-time and part-time status.

<u>Form A-2 Place of Origin of Students</u> - Using the same student classification as Form A-1, further classify students as in-state or out-of-state according to their <u>place of residence at the time of first admission to your institution</u>. Foreign students should be classified as "out-of-state."

Out-of-state institutions, including those with exclusively online delivery in Kentucky, should only report students who were Kentucky residents at the time of first admission.

#### FORMS B-1 AND B-2 - INSTRUCTIONS

#### NET CREDIT HOUR ENROLLMENT BY STUDENT LEVEL

Forms B-1 (Kentucky Resident) and B-2 (Out-of-State) are to be completed by listing the net credit hours for which students are enrolled based on student level. For example, consider a junior mathematics major who has the following course load:

- 3 hours lower division English
- 6 hours upper division Mathematics
- 3 hours upper division Chemistry
- 3 hours lower division History

If this student is a Kentucky resident, you would report on Form B-1 all 15 hours in the upper division category.

"Net credit hours" are total credit hours for which a student is enrolled as of the last day of the fall term on which students may add a course for credit. Credit hours for courses dropped on or before that day should not be included.

The "Technical/Semi-Professional" category should include all associate and certificate level student credit hours, except declared majors with CIP disciplines of 24, 30, 90, or 00. Student credit hours in these disciplines should be included in Lower Division.

Do not include doctoral dissertation residency credit hours, since these students are reported in a separate category on a headcount basis.

Out-of-state institutions, including those with exclusively online delivery in Kentucky, should only report students who were Kentucky residents at the time of first admission.

Degree-seeking students who have not declared a major are to be reported in 00.0000 (Not Designated/Undeclared).

Do not report Doctoral Dissertation students on Form C.

Seminaries should report students who are enrolled in the B.D. or M.Div. programs in the doctor's degree – professional practice category.

Out-of-state institutions, including those with exclusively online delivery in Kentucky, should only report students who were Kentucky residents at the time of first admission.

**JULY 1 - JUNE 30** 

Report undergraduate students who have transferred to your institution from the last institution at which they earned undergraduate-level academic credit.
