New Feature for Submitting Requested Additional Materials Related to the Final Progress Report

A new feature called FRAM (short for Final Progress Report Additional Materials) has been created for the Closeout module to provide a means for grantees to enter, review, route, and submit information in response to specific request(s) by the Program Official (PO) for additional information related to the Final Progress Report (FPR).

After reviewing the FPR, a PO may determine that additional information related to the FPR is required. In this event, the PO will submit a FRAM request. PIs will be notified of this request in the following manners:

- Email notification with specific information pertaining to the request
- *FRAM Requested* status on the *Closeout Status* screen on the line for Final Progress Report (see figures below)
- A **FRAM Update** link in the *Closeout Status* screen on the line for Final Progress Report (see figures below)
- **Closeout Final Report Additional Material Request (FRAM)** link in the **Other Relevant Documents** section of *Status Information* leading to the request

The **FRAM Update** link on *Closeout Status* opens the *Final Progress Report Additional Materials (FRAM)* screen, from which PIs can upload an attachment containing the requested information. The attachment must be a PDF format file, no larger than 6MB.

PIs also have the ability to route the FRAM to an SO, who will use the same screen for submitting it to Agency. Only the SO can submit FRAM.

To support this new feature, the following changes have been made to *Closeout Status* screen:

- New **Action** links on the Final Progress Report line of the table:
 - **FRAM Update** (for uploading and submitting)
 - **View FRAM** (for viewing after submission)
- New **Status** and corresponding **Result of Action** values on the Final Progress Report line of the table, automatically updated based on the actions taken throughout process:
 - *FRAM Requested by <PO Name>*
 - **Status:** *FRAM Uploaded*; **Result of Action:** *FRAM Updated by <PI Name>*
 - **Status:** *FRAM Submitted*; **Result of Action:** *FRAM Submitted by <SO Name>*

After the SO submits the FRAM to Agency, the **FRAM Update** link will be replaced by the **View FRAM** link. When the FPR is accepted, this link will be removed, and the submitted FRAM will be available to anyone with access to the *Status Information* for that grant using the

FRAM Submission link. If multiple submissions were made, these will be all display in one bookmarked, PDF document available from that link.

New Search Parameter on Closeout Search Screen for FRAM

The Status search screen for Closeout (available to SOs) has been updated to include a **Requires FRAM** checkbox. This box is marked by default and will ensure that search results include grants with FRAM requests.

Renamed the Link in Closeout Status for Viewing Submitted Final Progress Report

The link for viewing a submitted Final Progress Report in *Closeout Status* has been renamed. The former **View** link located on the Final Progress Report line of the hitlist has been renamed to **View FPR**. The link name was changed in support of the new FRAM feature associated with FPR.

The functionality of the link remains the same.

New Pilot Program for Federated Institutions/Organizations Login

eRA Commons is piloting Institution/Organization Log In functionality. The pilot is limited to those organizations currently registered with the Center for Information Technology (CIT). This piloted feature allows limited users at these registered institutions/organizations to use their organizations' credentials to log into the Commons system.

Roles eligible for the pilot are as follows:

- Graduate Student
- PostDoc
- Project Personnel
- Scientist
- Trainee
- Under-Graduate

The registered participants will log in using the **Federated Institutions/Organizations** field located below the **Commons Login** fields.

To use this feature:

1. Select your organization from the drop-down list and select the Sign In button.
2. Enter your organization's credentials when prompted.

If your organization credentials are linked to your Commons account, you will be logged in and ready to use Commons. Otherwise, you will be prompted to link your accounts.

No-Cost Extension

End of Month Dates Recalculated for No-Cost Extensions

Calculations determining project and budget end dates for no-cost extensions have been modified to take into account original end date months with less than 31 days. When a no-cost extension is applied to a project with an original end date on a month having less than 31 days (e.g., February 28), Commons will perform calculations to ensure that the new project end date is the last day of the new end date month.

For example, a project with an original end date of February 28 and a 3-month extension will now end on May 31. Before this update, the new end date of the project with the extension would have been May 28.

RPPR

New Inclusion Management System Accessible via RPPR Section G.

The Research Performance Progress Report (RPPR) now includes access to the new Inclusion Management System (IMS) for awards requiring inclusion enrollment data. If inclusion data is required on the RPPR, **Section G. Special Reporting Requirements** will reflect this in question **G.4.b Inclusion Enrollment Data**.

To report inclusion data, select the **Inclusion** link located in the **Inclusion Enrollment Report** block of question G.4.b. This link opens the *Inclusion–Manage Inclusion Data Records* screen of IMS where you will have access to planned and cumulative enrollment reports.

All reported inclusion data will be captured in IMS and accessible to Agency staff once the RPPR has been submitted. Additionally, the inclusion forms – both planned and cumulative enrollment – will be included in the PDF version of the RPPR.

Validations are in place to ensure that inclusion data has been properly updated before an RPPR has been submitted.

RPPR Available for all AHRQ non-SNAP Awards

Progress report submission using the RPPR module is now available for Agency for Healthcare Research and Quality (AHRQ) non-SNAP awards. Use of the RPPR does not change the current reporting due dates.

Commons IDs Required for Students Reported on RPPR

Individuals included in RPPR section **D. Participants** with a **Project Role** of Postdoc, Graduate, or Undergraduate are now required to have a Commons ID and to complete certain fields on their Commons Personal Profile (PPF).

The fields for the required information are located within the **Name and ID** and **Demographics** sections of the PPF and are as follows: Date of birth; Gender; Race/Ethnicity; U.S. Citizenship Status; and Country of Citizenship. Individuals may choose the option Do Not Wish to Provide where applicable.

In addition, individuals with the Graduate Student role are required to enter at least one degree, while those with a PostDoc role are required to enter a doctoral degree, including the name of the institution issuing the degree. This information is maintained in the Education section of the PPF.

If any of this information is missing, an error message displays when the Check for Errors or the Submit feature is selected for the RPPR. These errors will prevent the submission of the progress report. Prior to this release, missing PPF information resulted only in a warning.

The text next to question D.1 has been updated as follows:

A Commons ID is required for all individuals with a postdoctoral role and/or supported by a Reentry or Diversity Supplement. The Commons ID is strongly encouraged, but currently optional, for all other project personnel.

NOTE: These requirements are for NIH grants only.

IC Requested PRAM Link Renamed

The **IC Requested PRAM** link located on *Status Results* screens is now called **Agency Requested PRAM**. The functionality of the link has not changed.

Modified the G.4.c NCT Table for Multi-Projects

Question G.4.c of the RPPR has been modified on both the screen and PDF.

For the screen, users can now select multiple components for each added NCT number. Enter the NCT number and then select one or more components from the Component list using the Ctrl key for multiple selections. The NCT will only be listed once, with all components displayed next to it together, within one column.

The PDF has also been modified. Question G.4.c will now show a table on the Overall component displaying each NCT number once and all of its associated components.

Budget Forms Allow Searching for Organization by Secondary DUNS

Searches for organizations on a subaward budget form will recognize secondary DUNS numbers when retrieving results. However, only the primary DUNS will be populated on the form after an organization is selected from the search results.

eSNAP Only Checkbox Removed from Pending Progress Report Search Screen

The **eSNAP Only** checkbox has been removed from the Pending Progress Report Search screen as it is no longer a valid search criterion.

xTRAIN

Support Year Extension Added to 2271 and Termination Notice

When available, the support year extension will now display on the 2271 and Termination Notice (TN).

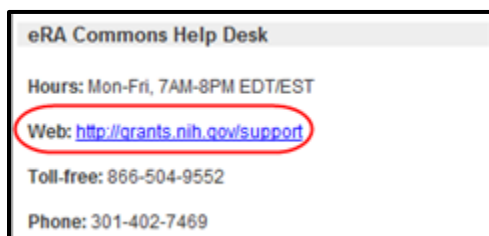


Figure 5: eRA Commons Help Desk New Website Address

Defects

Corrected Special Character Limitation in Passwords

Previously, passwords containing more than one special character in a row (e.g., Hello\$\$\$) did not work.

Resolution

This issue has been resolved. Commons passwords can contain any combination of special characters, as long as the other password requirements are met.

Corrected Text of Error Message on RPPR

The RPPR error message indicating that the Administrative Official assigned to the RPPR was missing information in the personal profile pointed to question A.2 as the section containing the error. This message was incorrect, as the error pertained to question A.3.

Resolution

This issue has been resolved. The text of the error message was corrected.

Corrected the Remaining Character Count in RPPR Section B. Accomplishments

It was reported that in certain scenarios, the remaining character count for text boxes in section **B. Accomplishments** from the screen. The count would return once the form was saved.

Resolution

This issue has been resolved.

Corrected the Validation Error Message for RPPR Question C.4.

Previously, the wrong validation error message displayed for question C.4 of section **C. Products**.

Resolution

This issue has been resolved.

Corrected Error in Congressional District Field on RPPR

Selecting the link providing as self-help in RPPR section **G. Special Reporting Requirements** caused an error.

Resolution

This issue has been resolved.

Added Missing HHS Logo to RPPR Section C. Products

Question C.5.b of the RPPR was missing the Department of Health and Human Services (HHS) logo.

Resolution

This issue has been resolved. The logo has been added to the question.

Non-Compliant Warning Message Fixed in RPPR C. Products

A non-compliant warning message should display when non-compliant publications were previously recorded and question C.1 is answered No. Previously, this warning did not display.

Resolution

This issue has been resolved.

Corrected Misspelling on RPPR PDF

Section E. Impact of the RPPR PDF had a misspelling of the word *manufacturing*. This word was spelled correctly on the screen.

Resolution

This issue has been resolved.

Addressed Sorting Issue for RPPR C. Products

It was reported that when sorting publications not associated with the project, RPPR displayed a blank page.

Resolution

This issue has been resolved.

Corrected Issue Preventing Organization Name in RPPR Greater than 60 Characters

It was reported that RPPR module stopped responding when attempting to add an organization name greater than 60 characters to the report.

Resolution

This issue has been resolved.

RPPR Link Now Displayed for ASST Delegated with Status and Progress Report Authority

Previously, ASST users delegated with Status and Progress Report authority were not able to see the **RPPR** link on the *Status Result–List of Applications* screen. These users were able to access it via the *Manage RPPR* screen.

Resolution

This issue has been resolved.
