### Updated DOJ Application Submission Checklist Available

Submitting an application for funding to the Department of Justice (DOJ) is a two-part process. To leverage the federal-wide [System for Award Management \(SAM\)](#) entity registration information, an applicant begins the application process in Grants.gov by submitting the required documents, including the SF-424 and SF-LLL. The full application is then completed in JustGrants.

The [DOJ Application Submission Checklist](#) was recently updated to help applicants submit their application in JustGrants. It provides step-by-step instructions and tips to help applicants complete their applications.

Specifically, the checklist outlines how to —

- confirm an applicant entity's System for Award Management (SAM) registration information;
- begin the application process by submitting an abbreviated application in Grants.gov;
- onboard an organization in JustGrants;
- complete the full application in JustGrants; and
- review, certify, and submit an application.
