Mean value of free medicine per application increased by 28.1%

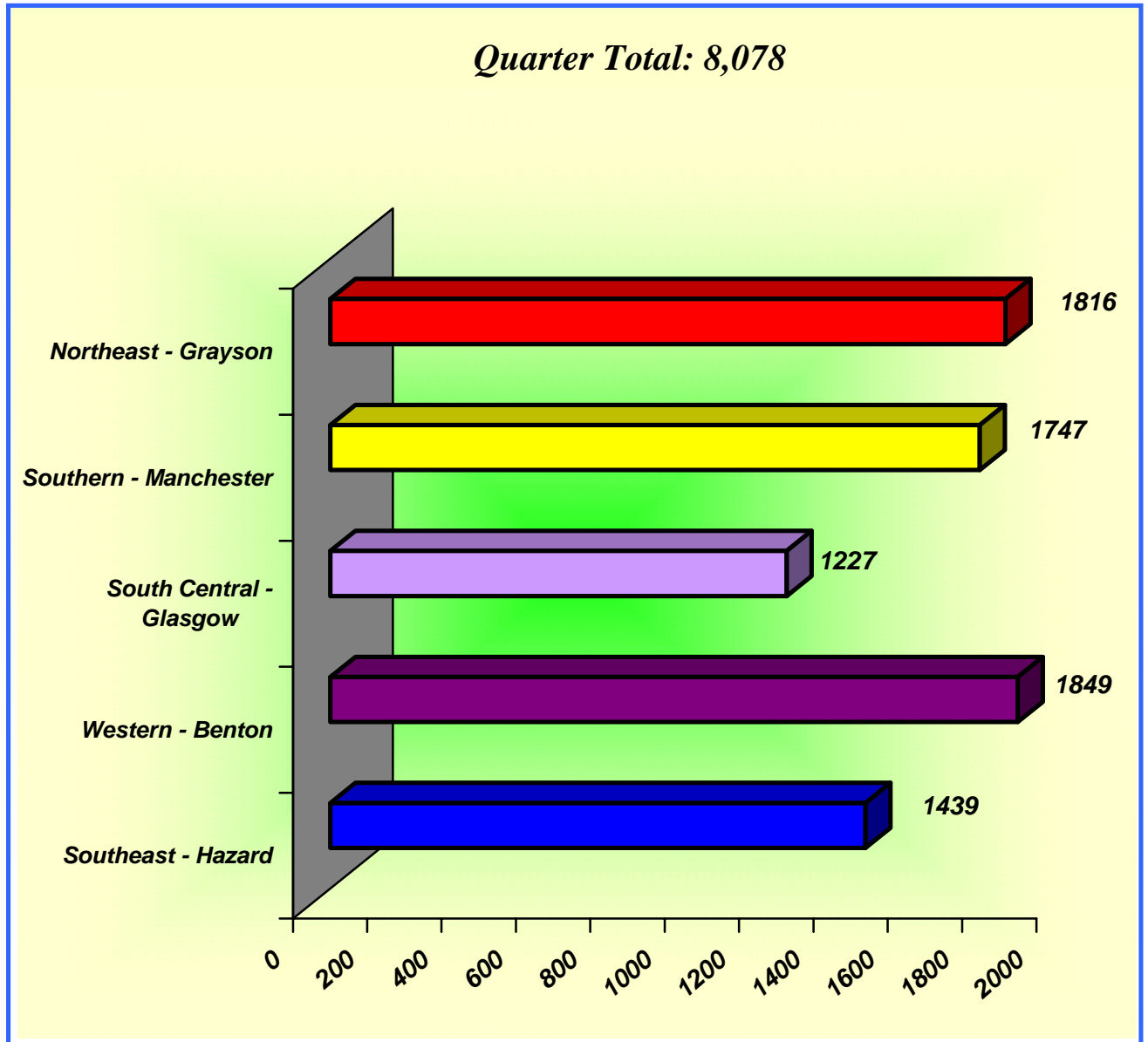
Total value of free medications accessed this quarter increased by 24%

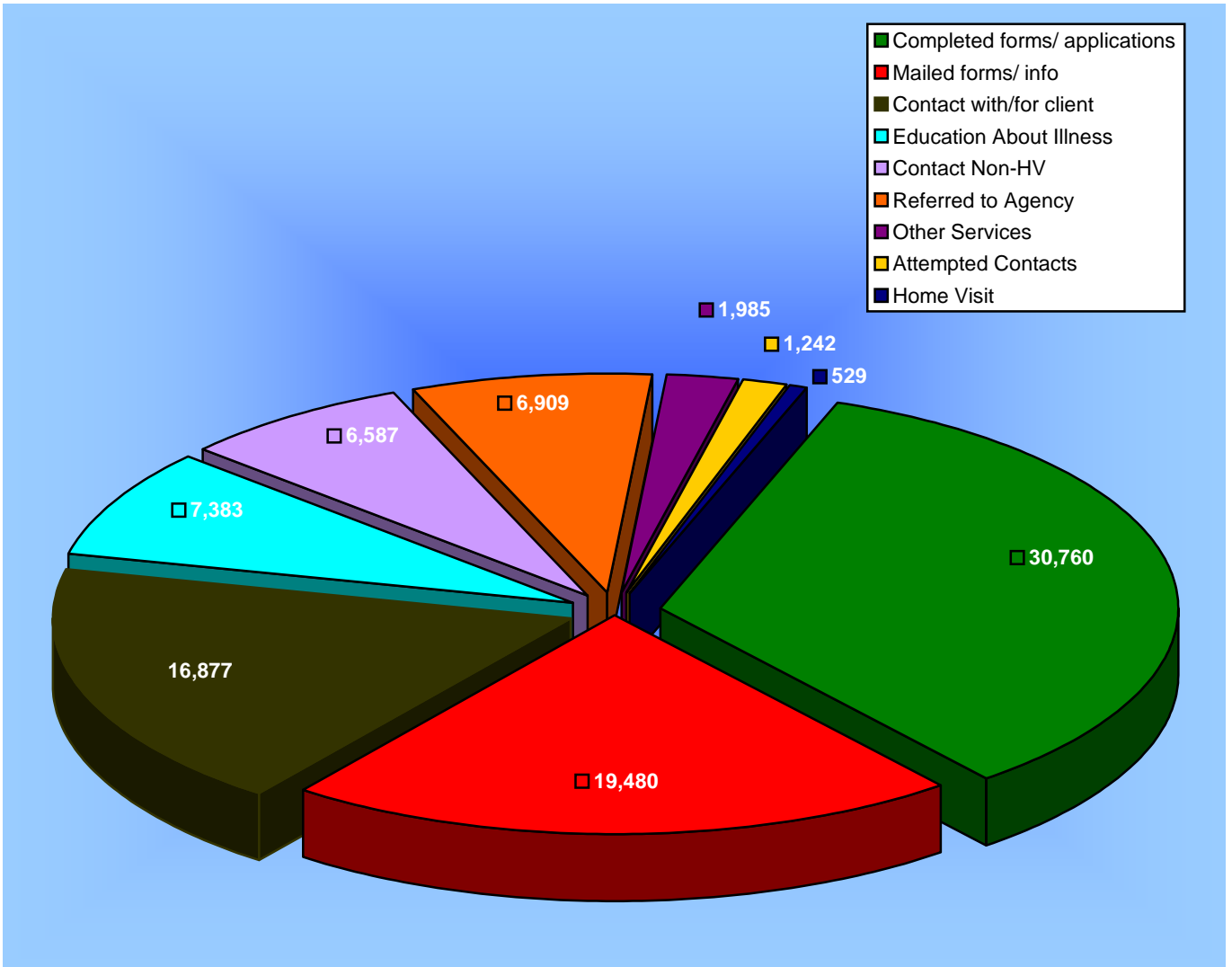

## Total Clients Served By Region January 1, 2005 – March 31, 2005



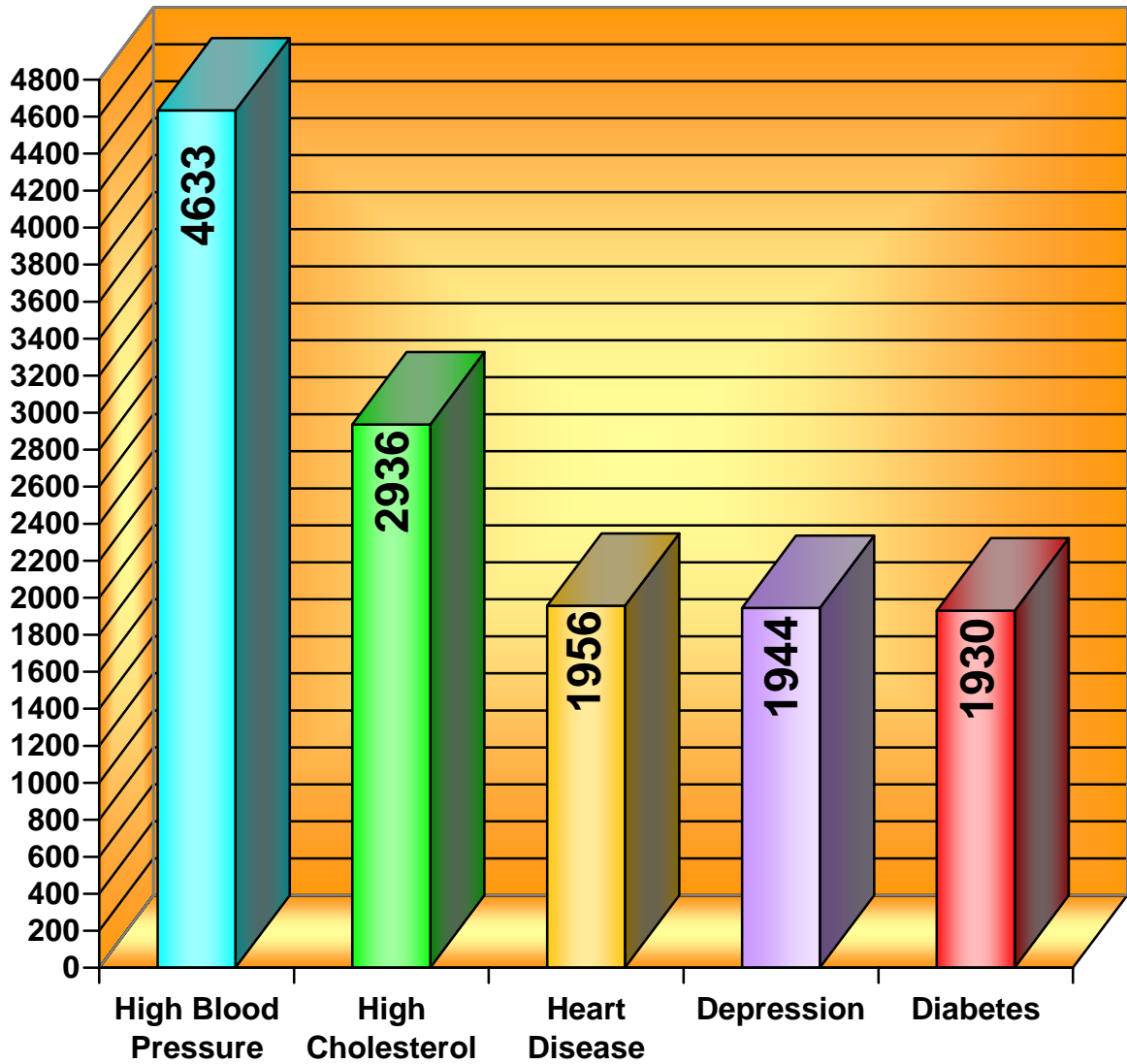

## **REGIONAL SUMMARIES**

### **January – March 2005**

#### **SOUTHEAST REGION – Breathitt, Floyd, Knott, Leslie, Letcher, Perry, Pike, Powell, and Wolfe counties; Regional Coordinator Lynn Whitaker.**

This quarter our family health care advisors served a total of 1,439 clients, performed 89 home visits, 1,384 client site visits, and provided 18,822 services. Medication in the amount of \$852,104 was ordered by the FHCAs in this region. All FHCAs completed sexual harassment training and attended the presentation of the film “Stranger with a Camera.”

#### **Knott County**

Paul Vance attended a computer and PowerPoint presentation training held at the UK Center for Rural Health (UKCRH). Paul attended the ARH Utilization Advisory meeting held at the ARH June Buchanan Clinic. This quarter Paul had 63 new clients, 141 client contacts and 2,930 services.

#### **Pike County**

Barbara Justice and Kristie Childers attended a computer and PowerPoint training held at the UKCRH. They attended a meeting with the Rehabilitation Counselor, Office for the Blind regarding New Eyes for the Needy. They attended the Centernet meeting held at the Pike County Library regarding the affects of colorectal cancer. They introduced Kentucky Homeplace to Betty Justice, patient financial counselor at the Pikeville Medical Center. They had three community health days at Elkhorn City. Barbara had 78 new clients, 191 client contacts and 2,056 services. Kristie had 59 new clients, 110 client contacts and 1,267 services.

with a representative from The Courier-Journal regarding Homeplace. This quarter Gina had 89 new clients, 189 client contacts and 3,084 services.

## **CLIENT ENCOUNTERS**

### **Actual situations encountered by our family health care advisors this past quarter**

---

My quarter has been very different this time. I have had the opportunity to work with and help people from other countries, such as Japan and Puerto Rico, who have migrated to the United States. I have learned that they work very hard for what they get, and are so very appreciative for what help that they did receive from Kentucky Homeplace. The Japanese people were very thankful that American people were so helpful and courteous and we were the only place that they could get any help with their medicines. The gentleman from Puerto Rico had worked all his life for a railroad company and had heart surgery and could not get any help, except from the Kentucky Homeplace. He was very pleased to get assistance with medicine and to know he could get help with eyeglasses. It has been a real experience working with other cultures. Kentucky Homeplace is becoming more and more popular every day and has been a blessing to so many people.

---

An 80-year-old lady was referred to me by the local pharmacy. She stated her prescriptions are costing her more than what she receives each month in Social Security and her daughter is helping pay her monthly bills, because she cannot do without her medications. I told her I would enroll her into the patient assistance program and would be able to get her medications free. I called His House Ministerial organization to see if they could help pay for some of her medications that she was almost out of until we got the indigent program going.

I asked the client if she had any money in a savings account or any assets and she answered “no”. I told her I was referring her to Community Based Services to see if she would meet the criteria for Qualified Medicare Beneficiary (QMB) on part B of her Medicare and to see if she would qualify for food stamps. I called them to set up an appointment for her and they said to send her right over.

The next day I received a call from my client and she was so excited she qualified for the QMB and was going to get \$150 in food stamps. She also told me she went to His House and was able to get some of the medications she needed. She said she did not know what she would have done if it were not for Kentucky Homeplace and was really grateful, for everything I did for her.

---

I met with 51-year-old lady who works full time at a local agency. She is divorced and has a son in college who still is living with her. She has insurance through her work but it does not cover eyeglasses. She averages \$1,100 a month but is paying bills that were left from her divorce and she is helping her son with college expenses. I applied for a New Eyes for the Needy voucher and due to her bills she was eligible for one. She was very thankful for the help. She also had a brother who was 54, had just been put in the hospital to have open heart surgery and didn't have any prescription coverage. She referred him for help because he would be put on several expensive medications. I was able to assist him also.

---

I received a phone call from a woman who desperately needed a hearing evaluation and I scheduled her an appointment. During her appointment I found out she had not had a hearing exam since grade school, and she is now 44 years old. As a child, she had 85 percent hearing and her hearing has gotten worse since then. I scheduled her an appointment for the exam, and completed the necessary paperwork. In our conversation it came up that she had not had a dental exam in a long time either. I was able to schedule her for a dentist appointment for a routine cleaning, exam, and X-rays. She also had gone to the eye doctor, and got a prescription for glasses. I completed the paperwork for her to get a voucher for her glasses as well. She was very appreciative that we could assist her with her needs. Preventative exams and procedures are often neglected because people cannot afford them. I was happy that this program was able to help this woman meet some of her medical needs.

---

This month I was rewarded by having the pleasure of assisting a young boy in need. He is 19 years old and has been diagnosed with having chronic pancreatitis. He lives at home with his family, a total of five people in the household and they have an income of less than \$580 a month. He is on several medications and has no health insurance. I was able to complete the indigent drug forms for the medications that were available for him. He and his mother were very appreciative of this program

---

Several months ago all FHCAs had to perform a survey on colon cancer. We had to ask our clients a few questions on if they had had a colonoscopy and a regular checkup having to do with colon cancer. A few months later I received a call from one of the clients that I had surveyed. She told me that the survey got her thinking that she needs to get screened for colon cancer since she had never given it much thought. The doctors instructed her to get a colonoscopy since the home test was a little abnormal. During the colonoscopy they discovered she had a few small polyps. The doctor told her that because they had caught it early, that there was minimal chance of it developing into something more serious. She just wanted to let me know that if it wasn't for that survey she never would have gone to the doctor, and things could have been a lot worse. I have since discovered that she passed away from other medical problems, but just think of the other lives we might have saved just by making them aware of how serious colon cancer really is.

---

A 38 year-old female came in requesting assistance with medications. Upon completing an assessment, I discovered that the client was considering filing for her disability due to problems with her diabetes and shoulder. It seems that she worked in fast food restaurants most of her life and when her diabetes got bad enough that she needed to check it two and three times a day she was not permitted enough time to do so and ended up passing out numerous times to the point of not being able to continue working. She then discovered that she had also dislocated her shoulder and was unable to work at all.

After completing forms for all her medications, we called vocational rehabilitation and scheduled an appointment for the following week for her to see a case worker. The client was very interested in returning to work but without insurance to obtain medications or see a doctor for shoulder problems her outlook on life was very grim. She is currently



recovering from shoulder surgery and has completed her GED. Once she has completely healed, vocational rehabilitation will retrain this client and help her find a position back in the workforce.

---

I was referred by an 89-year-old woman's physician for help with her medications. I called and scheduled a home visit. While doing the assessment, I discovered she was living on a \$364 Social Security check. I asked why she was not on SSI. She said she did not know that she could get SSI. I called the Social Security office and got a phone appointment. She wanted me to be there when they called. I was there and did the talking to the Social Security Office and got her signed up. She has received her first SSI check and a Medicaid card, which pays for her medications.

---

I recently received a call from a lady in New Jersey referring her ex-husband who is now living in southeastern Kentucky. The lady advised me that she had married and divorced him three times, but because of their past relationship, she felt obligated to help him with his medicines. The client is 60 years old with a history of alcohol abuse that had caused his health to deteriorate and had recently suffered a heart attack. The client does not have any medical insurance and has no income, although an application for DSSI is pending as well as applications for SSI and Medicaid. The client's wife and children were paying for his medical bills and medicines, but due to their own medical and financial situations could no longer afford to do so. The physician who was treating the client refused to see him any longer unless he paid in advance and even then the client could not afford his medicines. At the time I contacted the client he was getting desperate because he was running out of medicine and had no hope of seeing a doctor or obtaining his medicines. I called the local free clinic and was able to convince them to move this client to the top of the waiting list. The client kept his appointment and was enrolled as a patient. At this date, the client is receiving the medical attention he needs and the medicines he requires through the free clinic and various patient assistance programs.
