Preparation for International Travel Information Sheet for Exchange Visitor Physicians and J-2 Dependents

Minimally Required Documents

The following documents are minimally required for an individual in J status (J-1 or J-2) to reenter the United States following international travel:

- Passport, valid for at least six months beyond the program end date on the most recent Form DS-2019.
 Valid J-1 or J-2 visa. (Note: A visa is *not* required for Canadian citizens seeking to reenter the United States.)
- Original Form DS-2019 with travel signature in the *Travel Validation by Responsible Officer* box on the lower right side of Form DS-2019. Only ECFMG personnel can provide the required travel validation signature.

To Renew an Expired Visa Through a U.S. Consulate

An expired visa must be renewed through a U.S. Consulate prior to reentry to the United States. Exchange visitor physicians and accompanying J-2 dependents are advised to check their passports prior to departure and plan accordingly. If visa renewal is required, please allow adequate time for Consulate review and processing. The following documents are minimally required for exchange visitor physicians and J-2 dependents seeking visa renewal:

- Passport, valid for at least six months beyond the program end date on the most recent Form DS-2019.
- Original Form DS-2019 with ECFMG travel signature in the *Travel Validation by Responsible Officer* box on the lower right side of Form DS-2019.
- Application fee (check with the individual U.S. Consulate for fee amounts and accepted payment methods).

Travel to Canada, Mexico, and Adjacent Islands of the United States (Automatic Revalidation)

Under a provision of the U.S. immigration law termed "**automatic revalidation**," exchange visitor physicians and J-2 dependents who travel to **Canada**, **Mexico**, **and adjacent islands of the United States** (except Cuba) for *less than 30 days* are not required to have a valid J visa in their passports to reenter the United States as long as they hold valid U.S. nonimmigrant (J) status.

To qualify for automatic revalidation, an individual in J status must present the following to a U.S. Customs and Border Protection (CBP) Officer upon reentry to the United States:

- Passport, valid for at least six months beyond the program end date on the most recent Form DS-2019.
- Original Form DS-2019 with ECFMG travel signature in the *Travel Validation by Responsible Officer* box on the lower right side of Form DS-2019.
- Copy of Form I-94 reflecting status as "J-1; D/S".

NOTE: A visa is not required for Canadian citizens to reenter the United States; Canadian citizens should follow automatic revalidation procedures. **NOTE:** Citizens of Cuba, Iran, Sudan, and Syria are *not eligible* for automatic revalidation and require a valid J visa each time they reenter the United States.

When traveling to a country that is not their country of citizenship or permanent residence, exchange visitor physicians and their J-2 dependents are advised to consult that country's consulate in the United States prior to departure to determine if an entry visa is required.

VISA VS. VISA STATUS

Visa: The physical stamp affixed to a passport page reflecting the approved visa classification for which a foreign national may enter the United States.

Visa Status: The legal grouping under which the foreign national is categorized once physically present in the United States as identified by Form I-94.

FORM DS-2019 TRAVEL EXPIRATION

ECFMG travel-endorsed Forms DS-2019 are valid for multiple trips up to one year after the date of signature or the program end date listed on the form, whichever comes first.
