

Oyster Gardening Quick Facts

- ★ Shellfish must be grown either at your own private pier or otherwise **in the riparian area** of the shoreline of **your** waterfront property
- ★ Shellfish grown must be in containers: floats, cages, etc.
- ★ Total area of containers may not exceed 160 square feet
- ★ Shellfish grown are for **noncommercial** purposes only - you may not sell any shellfish grown with an oyster gardening permit.
- ★ The oyster gardening permit is a free permit
- ★ If approved, the permit lasts for 5 years and then must be renewed

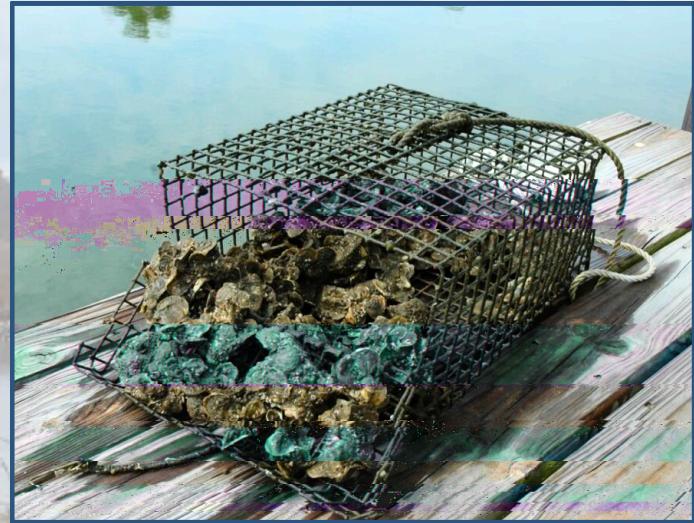

Oyster Gardening FAQ's

Q: Can I be issued an oyster gardening permit if my growing area is in condemned water?

A: Yes, the water quality status or quality classification of the water in the proposed growing area will not prevent you from obtaining an oyster gardening permit, **however**, you may not harvest oysters from condemned areas due to human health & safety concerns.

Q: Can I grow oysters at a community pier or boat slip that I have access to?

A: No, the VGP3 only authorizes waterfront property owners to install aquaculture structures at their own private property. If the proposed site is not your exclusive private property, you cannot install permanent aquaculture structures there.

Q: Where can I obtain an application for an Oyster Gardening Permit?

A: You can find the application on our website at:

Once submitted, the application will be processed and you will be notified via email upon completion.



Q: How can I renew my permit after 5 years?

A: Currently, the agency sends out reminders a couple of months before your permit expiration date along with an update form for you to fill out. You can fill this form out and send it back via email or by standard mail to the agency office.

Application for Oyster Gardening Permit, Virginia General Permit #3

Abbreviated Joint Permit Application for Non-Commercial Riparian Shellfish Aquaculture Structures

This application is intended to be used by persons applying for a permit to:

- Deploy up to 160 square feet of aquaculture structures in the tidal waters of Virginia.
- For the noncommercial culture of shellfish.

The Virginia Marine Resources Commission's General Permit #3 defines riparian shellfish gardening as:

- The grow-out of native shellfish species, in protective structures such as floats, bags, cages, etc.
- Adjacent to a private, noncommercial pier or otherwise within a waterfront property owner's riparian area
- Exclusively for private, noncommercial purposes.

The General Permit also specifies that the structures shall not adversely impact:

- Navigation
- Existing stands of submerged aquatic vegetation.

Application Process:

- VMRC will forward copies of the application to the Health Department and your local Wetlands Board for their review. The Health Department may contact you regarding shellfish handling and harvesting procedures if your project is being conducted in polluted waters.
- If you do not believe your project will meet these requirements for the General Permit, you should complete the standard Joint Permit Application rather than the attached abbreviated form. 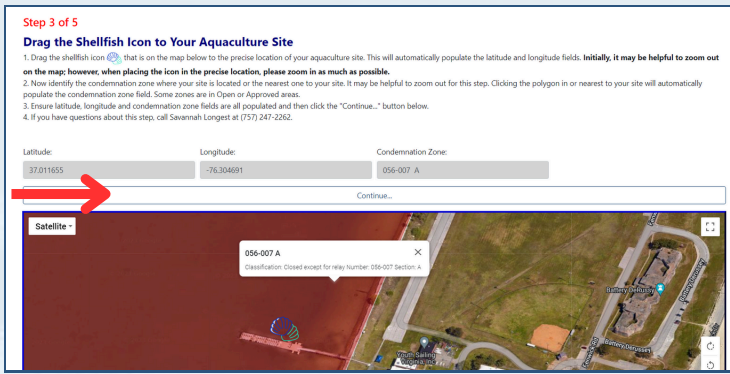

- This portion of the application locates the coordinates of your project. The map should generate at your project address. Then, click on the shell icon and drag it to the exact location your structures will be placed. The coordinates will generate automatically.

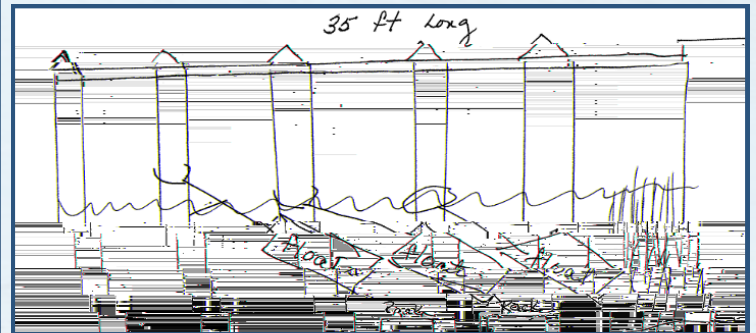
