

## Summary of 100% Smokefree State Laws and Population Protected by 100% U.S. Smokefree Laws

October 1, 2024

Population reflects only municipalities and states with ordinances or regulations that are *currently in effect* and do not allow smoking in attached bars or separately ventilated rooms and do not have size, age, or hours exemptions are listed here.

<sup>1</sup>Includes both public and private *non-hospitality* workplaces, including, but not limited to, offices, factories, and retail stores.

<sup>2</sup>Includes any attached bar in the restaurant.

<sup>3</sup>Includes freestanding bars without separately ventilated rooms.

<sup>4</sup>Includes only state-regulated, non-tribal gambling facilities. Tribal gambling facilities are sovereign and not covered by state laws. States marked as having smokefree gambling facilities include at least one of the following types of gambling: Non-tribal casinos and racinos, card clubs, race tracks, and/or jai-alai centers.

<sup>5</sup> Smoking is not permitted in 100% of rooms in hotels, motels, and other lodging establishments.

<sup>6</sup> The use of e-cigarettes and other electronic smoking devices is not permitted in venues required to be 100% smokefree by state law.

^ Enactment date does not include date for e-cigarette use laws.

N/A = State-regulated gambling not permitted.

\*Maine law requires state-regulated gambling venues opened after 7/2003 (including the state's 2 casinos) to be 100% smokefree.

Michigan law allows smoking in state-regulated gambling venues existing prior to 5/2010 (including Detroit's 3 casinos).

Alaska's 2018 law does not qualify for ANR Foundation's 100% smokefree non-hospitality workplaces, restaurants, and bars classification, due to a provision in the law allowing local jurisdictions to opt-out of the state's 100% coverage.

Altogether, there are 22,747 municipalities covered by either local or state 100% smokefree laws in at least one of the three main categories (non-hospitality workplaces, restaurants, and bars). Since some have 100% smokefree coverage in more than one category, **the numbers are not mutually exclusive**. Due to the possibility of overlap, it can be confusing to understand what each of the figures on our lists mean. **Please give us a call if you need help determining the population with a particular type of 100% provision, or a particular combination of 100% provisions.**
