Request Procedures: A request to inspect records must be made in writing, and may be submitted via US Mail, hand delivery, or electronic message to the Records Custodian. Online requests are also accepted via the online submission portal available at https://ppc.ky.gov/NewOpenRecords.aspx. The agency will comply with all laws, regulations, and internal policies concerning submission and processing of open records requests.

<u>Fees</u>: An agency may charge a reasonable fee for making copies of nonexempt public records for noncommercial purposes if physical copies are requested. For requests made for commercial purposes, the agency may recover the costs of media, mechanical processing, and staff time required to produce a copy of the records. You may be asked to certify whether your request is for a commercial purpose prior to records being produced.
