NEW PUBLIC HEALTH FACULTY

Dr. Shirley Thompson joined Dr. Rolf Lynton and Robert Lewis in the Department of Epidemiology as of January 1, 1977, as Associate Professor.

Dr. Stephen Durham, Associate Professor in the Department of Math and Computer Science, member of the School's Academic Advisory Committee from its very inception, has assumed the responsibilities of Director of Evaluation.

Ed Shmunis, M.D., a practicing dermatologist in Columbia, has joined the faculty of the Department of Preventive Medicine and Public Health on a part-time contractual basis to Public Health for the purpose of developing and teaching a course in Occupational Health, emphasizing medical aspects and toxicology. Previously Dr. Shmunis was staff member of the National Institute of Occupational Safety and Health.

This is the second course currently taught in Occupational Health. The other - in sampling analysis - is taught by Dr. Grady Callison, who combines his Public Health faculty appointment with his position.

as Assistant Director of the Bureau of Occupational Health and Safety with the Department of Health and Environmental Control.

Dr. Donald Robinson, M.D., Director of that Bureau in the Department of Health and Environmental Control, has joined Professors John Dolan, Ed Beardsley, and Rolf Lynton in teaching the course Health and Society, PUBH 711, to which his particular contribution on the history of South Carolina is a major new segment of the course.

RECRUITMENT OF FACULTY AND ADMINISTRATORS

To the ongoing search for a full-time Program Director for Public Health Nurses and chairman and faculty for the new Department of Epidemiology, the School has added a search for Associate Dean to pick up the half-time that Rolf Lynton will allocate formally to additional duties as Chairman of Preventive Medicine and Public Health in the School of Medicine, after July 1, 1977. The Associate Dean will assume administrative duties and also teach in at least one of the Programs.

THINKTIME IV: INFORMATION FOR HEALTH

POLICY MAKERS

The fourth in the series of Thinktimes with policy-makers, researchers, and practitioners took place in Columbia, February 13-15, 1977, on "Information Needs of Health Policy Makers." It was sponsored by the Office of Governor James B. Edwards. Collaborating with the School of Public Health were the South Carolina Department of Health and Environmental Control, the Medical University of South Carolina, and the new University of South Carolina School of Medicine.

Keynote speakers were Dr. William H. Kniseley, President of the Medical University of South Carolina; Dr. Keith E. Davis, Provost of the University of South Carolina; Dr. Robert Sparks, Director of Health Programs, Kellogg Foundation; and Dr. Rolf P. Lynton, Dean of the School of Public Health and Professor and Chairman, Department of Preventive Medicine and Public Health.

The seventy participants included representatives from the State Legislature, State and local agencies, the State Medical Society, Blue Cross-Blue Shield, and other voluntary and professional agencies, and HSA's. In addition, noted resource persons from outside the State were on hand from the National Institute of Health Statistics, National Institute of Health Services Research, DHEW Region IV (Atlanta), Rhode Island Health Services Research Center, and the Michigan State Legislature. An immediate outcome of the Thinktime was a recommendation to the Governor to empower a task force to examine possibilities for a comprehensive and on-going health data program.

This Thinktime was prepared with the on-going inter-agency group with which the School is developing its community-oriented programs for health information of use in health planning.

NEW LOGO DESIGN

The search for a logo design for the USC/SPH (School of Public Health) has concluded. The School is proud to display it for the first time on the masthead of this Newsletter. We are indebted to numerous people, departments, and schools for their dedication in working with us in our endeavors. In the final analysis, the Core Group reached consensus on a design which originated from Mary Gilchrist, a design student in the College of Journalism. Both the design and explanation formed parts of a laboratory assignment, thanks to the happy collaboration of Professor Lewis Brierley. Gilchrist explains the design thus:

The basic shape signifies the dynamic and progressive mood of the School of Public Health. The arrow shape signifies that the School is moving constantly upward and outward into the communities of the State. The figure-within-the-figure symbolizes the intent of the School of Public Health to serve all South Carolinians from infancy through the aging process. The basic shape represents a tree and the interdependence of man and his environment, and the importance of that relationship to the concept of total health. This aspect of the design intends to illustrate that the School is aware of and acknowledges problems to which it is committed to seek solutions. The crossed arms form a stylized cross - the universal symbol of health care. The external arms shelter and yet run parallel, indicating that the School of Public Health provides protective service to the State through various modes, working together with the public for the total health of South Carolina.

SOUTH CAROLINA PUBLIC HEALTH ASSOCIATION ANNUAL MEETING

The University of South Carolina School of Public Health is actively involved in many facets of the upcoming S.C. Public Health Association Annual Meeting. Dean Rolf P. Lynton and Program Director Robert Lewis are members of the Planning Committee for the Annual Meeting to be held June 2-4, 1977, at Hilton Head.

Dr. Winona Vernberg will co-ordinate a workshop entitled "Public Health Consequences of Outer Continental Shelf Development." Members of the workshop team are: Dr. Henry McKellar, Jr., The Baruch Institute; Clifford Hawkins, DHEC; Dr. Andy Laurent, State Budget and Control Board; Hardy Wickwar, Richland Memorial Hospital; Deborah Stirling, National Ocean Policy Study; and Larry Turner, School of Public Health, University of South Carolina.

A workshop entitled "Rethinking the Health Needs of Older South Carolinians," organized by Robert L. Sigmon and to be led by older South Carolinians, will focus on conditions in our communities which foster or impair good health. The workshop is designed for individuals in public health professions who seek to join some older South Carolinians in (1) rethinking health needs; (2) exploring ways to tap the resources of Older South Carolinians in planning; and (3) identifying areas of need for attention by public health organizations, professions, and professionals.

Panelists will speak on "Concerns of Older South Carolinians," "How Older South Carolinians are Organized," and "Programs and Issues in Preparation for Healthy Aging." Group discussions on these topics will follow, with a summary report by key Public Health officials responding to what they have heard and indicating themes for Public Health organizations, professions, and professionals to pursue.

The School of Public Health also will host an Open House on June 2, 1977, from 5-7 p.m., the location to be announced later. Staff, graduates, and students invite recipients of this Newsletter to visit with us on this occasion.

NEW POLICIES FOR ADMISSION

The third class of students to be enrolled in the School of Public Health will begin their studies in the Fall 1977 term.

The initial two classes began their studies with an intensive five week, seven academic credit Summer Session II Program. Beginning with the Fall 1977 term the School of Public Health will be admitting students to begin studies each fall and spring semester.

Students admitted during the Fall 1977 semester will be admitted under the existing 38 hour degree program. Students admitted to begin in the Spring 1978 term will follow a revised curriculum design.

The School's programs remain designed primarily for public health workers already committed to improving health conditions in South Carolina and the Region. In Environmental Health, Health Measurement, and Health Education, additional programs are to be initiated this fall designed to attract new people to these needed and growing public health fields.

Individuals interested in School of Public Health courses can be admitted as non-degree students. No application fee is required for non-degree students. Non-degree students who later decide to enroll cannot be guaranteed that all credits earned will count toward the degree, but case-by-case decisions will be made by appropriate Program Directors.

PROFILE OF STUDENT WORK ACTIVITIES IN PUBLIC HEALTH PRACTICE - SPRING 1977

Forty-nine students are working with seventeen public and private groups during the Spring Semester, 1977. One of these groups - Department of Health and Environmental Control-has thirteen different divisions which are currently sponsoring student work activities. Each student has developed specific work agreements jointly with their faculty sponsors. Weekly and bi-weekly seminars are being conducted with faculty and students participating. A workshop for mentors was conducted on December 16th to further clarify the Mentor Role in Public Health Practice.
