END USER LICENSE AGREEMENT

IMPORTANT: PLEASE READ THIS LICENSE CAREFULLY BEFORE USING THIS SOFTWARE.

1. LICENSE

By receiving, opening the file package, and/or using SOS Explorer(TM) Mobile ("Software") containing this software, you agree that this End User User License Agreement (EULA) is a legally binding and valid contract and agree to be bound by it. You agree to abide by the intellectual property laws and all of the terms and conditions of this Agreement.

Unless you have a different license agreement signed by Colorado State University (CSU) your use of SOS Explorer(TM) Mobile indicates your acceptance of this license agreement and warranty.

Subject to the terms of this Agreement, Colorado State University (CSU) grants you a limited, non-exclusive, non-transferable license, without the right to sub-license, to use SOS Explorer(TM) Mobile in accordance with this Agreement and any other written agreement Colorado State University (CSU). Colorado State University (CSU) does not transfer the title of SOS Explorer(TM) Mobile to you; the license granted to you is not a sale. This agreement is a binding legal agreement between Colorado State University (CSU) and the purchasers or users of SOS Explorer(TM) Mobile.

If you do not agree to be bound by this agreement, remove SOS Explorer(TM) Mobile from your device now and, if applicable, promptly return to Colorado State University (CSU) by mailing any copies of SOS Explorer(TM) Mobile and related documentation and packaging in your possession.

2. DISTRIBUTION

SOS Explorer(TM) Mobile and the license herein granted shall not be copied, shared, distributed, re-sold, offered for resale, transferred or sub-licensed in whole or in part, except that you may make one copy for archive purposes only.
