HOW DOES THE ACA CHANGE HEALTH CARE DELIVERY?

- More people will have health insurance
- More people eligible for Medicaid coverage
- More people with employer-based health insurance
- More people with private insurance (Individual Mandate)



HOW DO THE ALLIED HEALTH PROFESSIONS AID THESE CHANGES?

- Many Allied Health Professionals specialize in providing the services outlined and emphasized by the ACA.
- Allied Health Professionals can assist in efficiently serving the increased number of people who will be able to afford health care services.
- Allied Health Professionals are prepared to meet the changes in emphasis.
 - They have experience working in teams
 - They use valid and reliable outcome measures
 - They specialize in areas directly related to prevention, wellness, and management of chronic diseases
 - They work in out-patient, home health, and school-based settings

WHAT EDUCATION AND RESEARCH ASSISTANCE DO ALLIED HEALTH PROFESSIONALS NEED TO BE SUCCESSFUL?

- Many Workforce and Funding Initiatives do NOT currently include MOST Allied Health Professionals
- Health Care Workforce Initiatives that DO Include some Allied Health Professionals:
 - Geriatric Career Incentive Awards (Section 5305)
 - School-Based Health Centers (Section 4101)
 - Allied Health Workforce Recruitment and Retention Program
 - Mid-Career Public and Allied Health Training Scholarships (Section 5206)
- Research funding should include Allied Health Professionals since they may increase quality/efficiency/effectiveness of service for a lower cost.
