Custody Witness Checklist

I. Witness and Knowledge of the Case

- 1. Name and address?
- 2. Number of children of witness and ages?
- 3. How long have you known client?
- 4. How often do you see the client with the children of the parties?
- 5. What are the circumstances under which you see the children--visit the home, etc.?
- 6. Have you seen the children interact and associate with your client? And with the spouse?

II. Fitness of the Parents

- 1. What is the character and reputation of the parties?
- 2. Has either parent exhibited an adulterous relationship to the children?
- 3. Has either parent exhibited an inability to hold a job? Why does he change jobs? How long is present job?
- 4. Has either parent exhibited a lack of stability?
- 5. Are the parents responsible or irresponsible?
- 6. Has either party ever voluntarily abandoned or surrendered this child or any other child?
- 7. Has either party ever failed to provide for or care for the children?
- 8. Does either party use alcohol to excess?
- 9. Does either party use drugs?
- 10. Has a party shown violence or quick temper to spouse or children?
- 11. Does a party use profanity around the children?
- 12. Is a party a poor housekeeper?
- 13. Can the party cook?
- 14. Is a party too old or infirmed to care for children?
- 15. Is a party subject to periods of depression, suicide threats or attempts, or other indications of emotional illness?
- 16. Does a party disparage or run down the reputation of the other party to the children?
- 17. Does one parent abuse the other, physically or mentally, in the presence of the child?
- 18. Has a parent ever interfered with the relationship of the other parent with the children, such as denied visitation?
- 19. What are the goals and values of each parent?
- 20. What is the lifestyle of each parent as a role model for the child?
- 21. Which parent can offer the children the best career motivation?
- 22. What is the economic situation of each parent, and ability to provide financially for the child?
- 23. What are the best and worst aspects of the other spouse?
- 24. What are the best and worst aspects of the client? What can the other spouse say about client? (Bring out possible problem areas)

III. Child Factors (What is parent's involvement in each factor?)

- 1. What is the present de facto custody of the child?
- 2. What is the child's needs for continuity and stability?
- 3. What is the age, appearance, and sex of the child?
- 4. Describe the present living arrangements of the child.
- 5. Does the child have his own room, toys, and adequate clothing?
- 6. Describe the house and yard.
- 7. What is the child's physical and psychological/mental history?
