1. Login to the Positive Pay System.
2. Click on the **Submit Issued Check File** button.

Step 1

Click the browse button and select the file name.

Step 2

Client ID: Select the client id associated with issued check file.
File Processing Type: Select the format of the issued check file.
Items in File: Enter the total number of check in the file.
Dollar Amount in File: Enter the total dollar amount of all the checks in the file.

Step 3

Click the **Process File** button.

Note: If the total items in the file or the total dollar amount in the file does not match actual number of checks in the file, then the file will be rejected.

3. View the current status of all uploaded issued check files. Click on the **Issued Check File Processing Log** button.
