

LifeSize Video Conferencing Guide

Introduction

This guide will provide instructions and information to enable members of the public to attend Division of Workers' Compensation (DWC) trials via video conference.

DWC currently uses a video conferencing product called LifeSize. This document will go over the installation and testing of LifeSize on a desktop computer.

Prerequisites

System Support Requirements for LifeSize video conferencing system

- Webcam
- Microphone/Speakers or USB Headset
- Computer with following specifications:
 - Mac OS X or Windows
 - Quad Core CPU
 - 2 GB RAM (more is recommended)
 - Webcam, microphone, and speakers
- Reliable, consistent internet connection with minimum speed of 1 megabit/second

LifeSize on phone and tablets

- LifeSize software is available for Android phone/tablets and IOS (iPhone and iPad).
- The LifeSize download page has buttons for Android and IOS software installation.
 - When you attempt to install LifeSize, you will be notified if it is compatible with your particular device.

After clicking the Join button, you will see the Audio/Video Set up window below. Set up your audio/video per screenshot below.



Controls available during a video call

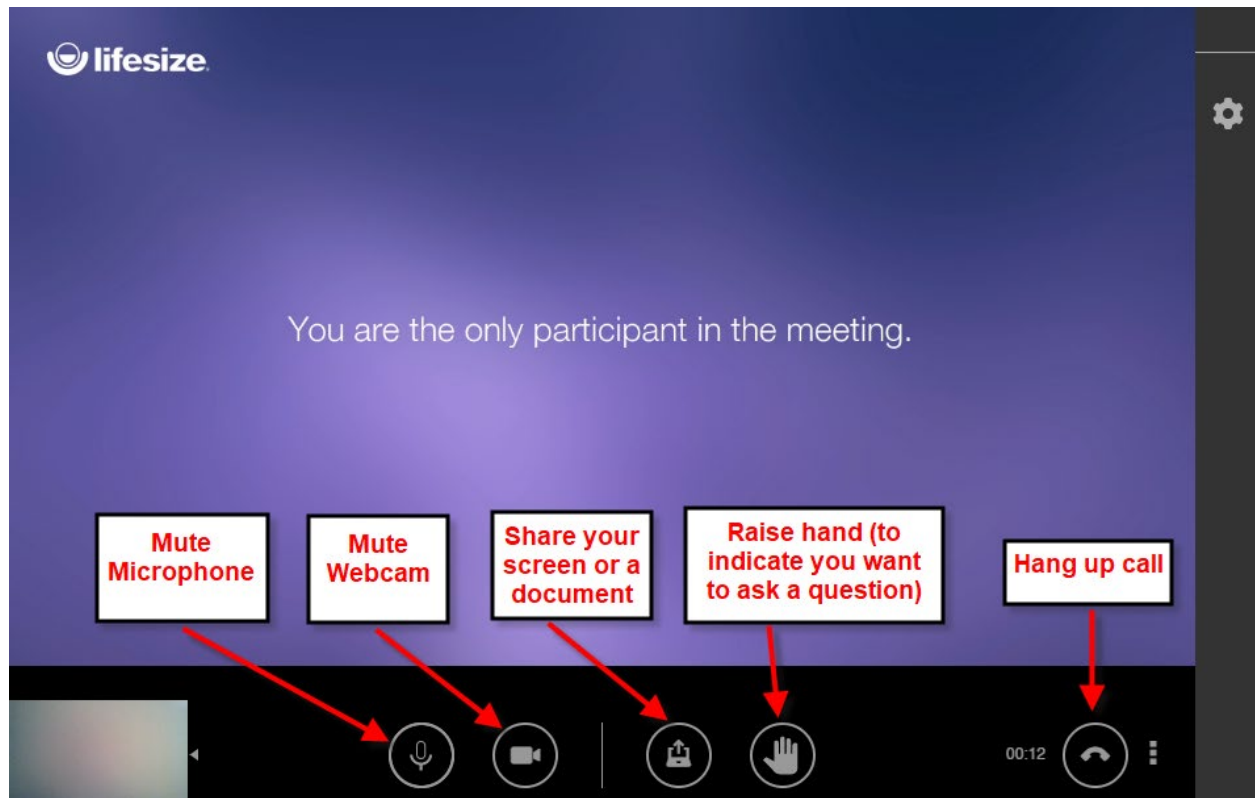


Figure 3 Controls available during a video call. Control include muting video, muting audio, and hanging up.

Virtual Conference Room for Testing Video Calls

A virtual conference room has been created for members of the public to call into for testing. An attorney and their client can call into the conference room to see and talk to each other. This will enable the attorney to verify, prior to the trial, that the client/injured worker has the necessary equipment and software for a successful video call. All parties should be aware that DWC will not be monitoring this virtual conference room. The room is not private, and other participants may be using it. The room may be used for test purposes only.
