2025-27 Capital Project Funding Request for the Natural Areas Program

MAINTAIN AND IMPROVE THE DNR'S 97 NATURAL AREAS ACROSS 170,000+ ACRES STATEWIDE.

DNR's Natural Areas have been acquired for the purpose of:

- Protecting ecosystems and habitat for rare or endangered species.
- · Retaining important scenic and cultural values; and,
- Providing opportunities for educational, scientific, and other low-impact recreation or environmental education uses.

This small works capital project funding will support public access and facility preservation on 33 DNR Natural Areas in 18 counties and 14 Legislative Districts.

The 38 projects include:

- Parking and trailhead facilities
- Road maintenance improvements
- ADA access
- Fences and gates
- Trail renovations, connections, and road-to-trail abandonments
- Pedestrian and vehicle traffic
- Toilet relocation and installation
- Kiosks and interpretive shelters
- Viewing platforms
- Environmental education signage
- Relocating or renovating campsites
- Demolition of dilapidated structures
- Interpretive building preservation
- Culvert Removal
- Survey's, design, and permitting for capital projects



PROTECTING THE PUBLIC'S INVESTMENT

These projects are prioritized to achieve multiple goals of public access, environmental education, and conservation. Development and preservation of facilities and infrastructure in conservation areas or within preserve buffers, are key strategies to providing appropriate public access while protecting the public's investment in conservation features.


IN PERPETUITY
