EXPLANATION OF MATERIAL TRANSMITTED:

Exhibit 845 provides a comprehensive list of mileage rates from October 24, 1980 to the present. The General Services Administration has announced that starting January 1, 2018, the latest mileage rate is 54.5 cents per mile. Exhibit 845 has been updated to include this new rate.

Miner medical travel should be reimbursed at the rate which prevailed when the travel occurred. Travel claims paid at a previous rate may be resubmitted for adjustment.
