

Errata Note: 2022 EAVS Comprehensive Report and Accompanying Dataset

December 18, 2023

The states of Delaware, Hawaii, West Virginia, and Wisconsin requested to make corrections to their data submissions for the 2022 EAVS following the initial publication of the comprehensive report and dataset on June 29, 2023. These corrections are documented below.

2022 Election Administration and Voting Survey Dataset

The corrections listed below are reflected in Version 1.1 of the 2022 EAVS dataset released in December 2023.

- Delaware and Hawaii provided updated total number of voters removed from the voter registration rolls (A9a) and updated total number of voters removed due to their failure to respond to confirmation notices sent and failure to vote in the two most recent federal elections (A9e). Statewide and nationwide A9a & A9e totals did change.
- West Virginia provided updated total number of UOCAVA absentee ballots returned (B9a), total number of UOCAVA ballots returned by postal mail (B15a), total number of UOCAVA ballots returned by email (B16a), the number of jurisdictions that use scanners (F8a), the make and model of the scanner (F8b_1), and the number of scanners deployed (F8c_1). Statewide and nationwide B9a, B15a, B16a, F8a, F8b_1, & F8c_1 totals did change.
- Wisconsin provided an update to their response to Q36 in the Policy Survey on the auditing activities that their state conducted in 2022. Nationwide Q36 data did change.
