Subject: Approval of Georgia Electric Vehicle Infrastructure Deployment Plan

Dear Commissioner McMurry:

The Federal Highway Administration (FHWA) has completed the review of the Georgia Electric Vehicle Infrastructure Deployment Plan required under the National Electric Vehicle Infrastructure (NEVI) Formula Program.<sup>1</sup> Based on the review and the recommendations provided by the Joint Office of Energy and Transportation (Joint Office), FHWA has determined that the Georgia Electric Vehicle Infrastructure Deployment Plan is approved for implementation. With this approval, Fiscal Year 2022 funds are now available to Georgia for obligation.

The following table details exceptions that were requested in the Georgia Plan and the approval determinations by FHWA.

I-20 Conyers	1-mile proximity to corridor	Approved
I-575 Kennesaw	1-mile proximity to corridor	Approved
