This project provided base-line data on the distribution and abundance of threatened and endangered sea turtles prior to the proposed redirection of Everglades fresh water flow. Tagging data are located on hard copy and electronic versions on CD. They are not posted on the host server. A condensed version of these data was also submitted to the Cooperative Marine Turtle Tagging Data Base (CMTTP) administered by the University of Florida, Gainesville, FL.
