Process Steps:

- 2008-01-01 00:00:00 - Net / Trawl Operations: Operations varied, utilizing either neuston, bongo, Methot, or 1 meter Multiple Opening and Closing Net Environmental Sampling System (MOCNESS) . Trawl type and location was

dependent on the work area (depth). Plankton samples were collected at sea and preserved in Ethanol. Light trap, channel net operations were done daily and consisted of larval fish collections. Seine tows were done three times around the new moon to monitor recruitment of settlement size fishes. Sorting and identification of larval fish began immediately. All data was stored in a spreadsheet format and updated as samples were completed.
