Seasonal capture efforts were conducted to evaluate patterns of catch rates, species and size composition. Acoustic and satellite telemetry were used to evaluate residency, movements, and dive behavior. AUV-borne sidescan sonar surveys were conducted at the peak of sea turtle abundance on the spring.
