the database. Similarly, longline set locations and environmental data were collected on paper and then manually entered into database. All data were thoroughly scrutinized by watch leaders at sea and then again checked for accuracy at the end of each survey. Once considered complete and accurate, data were transferred to the custodian.

In addition, Security benchmarks are applied to the database and host environment. Data residing in the centralized database (Oracle) is backed up nightly. Backup sets are placed on the laboratories' Networked Attached Storage (NAS) environment. Security patches/updates are immediately applied to the host environment. Data is stripped/mirrored using RAID 50 technology to protect data from disk failure. Nightly backups are preformed and files are written to magnetic tape and stored in an onsite / offsite location.
