## 1. General Description of Data to be Managed

### 1.1. Name of the Data, data collection Project, or data-producing Program:

ROUNDSCALE SPEARFISH branchiostegal morphometric data

### 1.2. Summary description of the data:

The morphometric characteristics that separate white marlin *Kajikia albidus* from roundscale spearfish *Tetrapturus georgii* can be difficult for non-experts to distinguish, particularly when the animals are in the water. Using the measurements of the lower jaw tip to the longest branchiostegal ray (LJBR) and the opercle (LJOP), a discriminant function is presented that will help field observers separate the two species. The function  $DR-W = LJBR(3.31861) - LJOP(-2.84856) + 6.37198$  classified specimens as roundscale spearfish when  $DR-W > 0$  and as white marlin when  $DR-W < 0$  with a 95 correct classification rate overall. Since only the head of a specimen needs to be closely observed, the method has particular utility for tournament anglers during the hook removal process.
