San Antonio Bay 1986-1989

1.2. Summary description of the data:

The effect of salinity on utilization of shallow-water nursery habitats by aquatic fauna was assessed in San Antonio Bay, Texas. Overall, 272 samples were collected in a variety of marsh, vegetated, and non-vegetated habitats throughout the Bay system. Sampling began in fall 1986 and extended through fall 1989. Vegetated habitats, marsh, and submerged aquatic vegetation has significantly higher densities of fishes and decapod crustaceans than bare mud habitats.

5.1. Processing workflow of the data from collection or acquisition to making it publicly accessible

Process Steps:

- After sample collection, field data were entered into an Excel spreadsheet or database file (DBF) using database manager software. A text file was created to

describe these data and associated variables. Entered data were checked against the field sheets by two biologists to minimize entry errors. Samples were processed in the laboratory, sorted, specimens identified and measured, and information was entered into an Excel spreadsheet or DBF file. Files were printed out and compared against original data sheets by two biologists for data entry errors. Corrections were made at this time, the electronic file was saved, and a back-up copy made. Hard copies of the QCd files were printed and stored in the project folder along with the original field and laboratory data sheets. The electronic file was also sorted and examined by the Lab Supervisor or other project personnel in a variety of ways to look for outliers, missing data, and other potential errors. Verified data files were then saved electronically on the Galveston Laboratory server and backed-up as needed.

5.2. Quality control procedures employed (describe or provide URL of description):

Quality control was provided by comparing field data sheets and specimen identification (ID) sheets against the entered data print-out. One biologist read from the field data or specimen ID sheet while a second biologist checked the data entry print-out. Corrections were made at this time and saved. The project data manager also examined these corrected data, and sorted these data in a variety of ways to look for outliers, missing information, and other potential errors.
