### 73<sup>rd</sup> Annual Meeting

October 16 - 19, 2022

The Gulf States Marine Fisheries Commission's 73<sup>rd</sup> Annual Meeting will be held October 16-19, 2022 at the San Antonio Marriott Riverwalk in San Antonio, Texas. This notice contains meeting details, including the preliminary meeting schedule. All of the business meetings scheduled during this week are open to the public. Please note the preliminary schedule is subject to change. Mr. Doug Boyd, State of Texas Private Citizen Appointee, is the presiding Chairman of the Commission.

**ACCOMMODATIONS:** Texas is our host state and arrangements have been made to convene at the San Antonio Marriott Riverwalk (889 East Market Street, San Antonio, TX 78205). Right outside the doors, the River Walk has it all! From world-class dining to exploring century-old missions, San Antonio resonates in the heart of its visitors with an authentic culture. Take one of the famous River Boat cruises, offering stories of San Antonio history and architecture. It is also a short walk to landmarks including the Henry B. ## **LYLES – SIMPSON AWARD**

The Gulf States Marine Fisheries Commission previously announced that the 2020 Lyles-Simpson Award had been awarded to Harriet MacGill Perry. This prestigious Award is presented annually to an individual, agency, or organization which has contributed to the betterment of the fisheries of the Gulf of Mexico through significant biological, industrial, legislative, enforcement, or administrative activities.



Harriet has been involved in the marine fisheries world for 50 years. Over those years, she has been an educator, researcher, and collaborator in the disciplines of environmental science and aquatic biology. Her primary interests include the research of Brachyuran (true) crabs, population dynamics of estuarine and marine invertebrates, invertebrate taxonomy, blue crab aquaculture, invasive species, and management of marine fisheries. In addition to these studies, she also has mentored, trained, and educated people around the entire Gulf of Mexico, ranging from fishermen, to environmental groups, to students, and scientists. She has been participating with the Gulf States Marine Fisheries Commission for numerous years, and has been a long-time member of the Commission's TCC Crab Subcommittee. She has also played an integral role in the development of an update of the Commission's Blue Crab Fishery Profile.

It is with great pride that the Gulf States Marine Fisheries Commission presents the 2020 Lyles-Simpson Award to such a worthy recipient. A reception/dinner to present this award and honor Harriet is scheduled for Monday, October 17 beginning at 5:30 pm.
