RECOMMENDATION:

That the Board:

1. Approve the request of the United Food and Commercial Workers International Union (UFCW) Local 770 Icaza Foundation to hold their 12<sup>th</sup> Annual Charity Golf Tournament at the Woodrow Wilson and Warren G. Harding 36-Hole Golf Complex (Wilson/Harding Golf Complex) on Monday, September 18, 2006, beginning at 8:00 a.m., with a 10:00 a.m. double shotgun; and
2. Direct staff to issue an exclusive use permit to the UFCW Local 770 Icaza Foundation in accordance with the terms described in the body of this report.

SUMMARY:

The UFCW Local 770 Icaza Foundation requests exclusive use of the Wilson/Harding Golf Complex on Monday, September 18, 2006, for their 12<sup>th</sup> Annual Charity Golf Tournament, the Group's second tournament held at City courses. The event will begin at 8:00 a.m. with a 10:00 a.m. shotgun tournament followed with an awards banquet. Proceeds from the event benefit leukemia research in the quest to defeat leukemia, lymphoma, and myelodysplastic syndromes.

Golf Tournament Policy permits shotgun golf tournaments on Mondays, but limits tournament access to one of the two golf courses at 36-hole facilities per day. The tournaments would begin at 10:00 a.m. and should be completed by 3:00 p.m., permitting public play after the tournament. Play has declined on City golf courses, as well as throughout the country. This tournament will benefit the Department as it is an opportunity to promote City of Los Angeles golf courses to numerous sponsors, members, and out of town guests.

Approval of this request is recommended subject to inclusion of the following provisions in the exclusive use permit to be issued to the UFCW Local 770 Icaza Foundation:

- The UFCW Local 770 Icaza Foundation is required to pay a rental of \$16,590 for a minimum of 128 players at each course. The fee for each additional player will be \$53 per player. The fee includes compensation for loss of green fees and reimbursement for salaried overtime and materials and supplies required for the tournament. The funds will be deposited into the Golf Operation account (Fund 302, Department 89) from which green fees are paid to the City General Fund and from which overtime salaries are paid.
- Comprehensive General Liability insurance of \$1,000,000, including personal injury, products, contractual and liquor liability, is required with the City as additionally insured.
- The Wilson/Harding Golf Complex Starter Supervisor and the Griffith Area Senior Golf Maintenance Supervisor are designated as the Department tournament liaisons.
- The UFCW Local 770 Icaza Foundation will negotiate separately with Department concessionaires at the Wilson/Harding Golf Complex for carts, food, and refreshments, including alcohol.

The Golf Advisory Committee is aware of this event. The fees collected from the tournament are sufficient to pay all green fees and cover any overtime and/or necessary extra maintenance materials.

FISCAL IMPACT STATEMENT:

Regular non-tournament weekday green fees are \$22 per person. The rental fee for this double shotgun tournament is \$53 per player for a minimum of 256 players and an additional \$3,022 for operations and maintenance overtime expense. Since Mondays are light play days, the premium green fees paid by the tournament are anticipated to exceed the typical revenue for a Monday.
