RECOMMENDATION:

That the Board:

1. Authorize a Memorandum of Understanding (MOU), substantially in the form on file in the Board Office, between the Department of Recreation and Parks (RAP) and the Department of General Services (GSD) for the fabrication and installation of 17 signs at various Recreation and Park facilities, as required by the State's Proposition 12 Per Capita Grant Program, subject to the approval of the City Attorney as to form;
2. Direct the Board Secretary to transmit forthwith the MOU to the City Attorney for review and approval as to form;
3. Authorize the Department's General Manager to execute the proposed MOU, upon approval as to form by the City Attorney;
4. Authorize the Department to cash flow \$7,357 from Fund 205/88/AR01 to fund eight Proposition 12 Per Capita project signs to be reimbursed by Proposition 12 Per Capita Grant Program funds upon receipt of the Proposition 12 grant project retention funds; and
5. Authorize the Department's Chief Accounting Employee, subject to Council approval, to request the City Administrative Officer to process a transfer of funds in the amount of \$17,867 from the following fund and account numbers under the awarding authority of this Board Report:

SUMMARY:

Pursuant to the Proposition 12 Grant Program guidelines, the Department, as the designated grantee, is required to provide project signage for each Proposition 12 completed project. Seventeen (17) Proposition 12 projects have completed construction at various Department facilities. Only one sign was constructed for projects with more than one State funded project. The cost of the sign was split equally between the projects.

To finalize and closeout these 17 projects, the Department requested the Department of General Services to fabricate and install the needed signs as specified in the Proposition 12 Grant Program guidelines. The Department of General Services has agreed to enter into an agreement with the Department to complete the 17 project signs at an estimated cost of \$1,051 each, totaling \$17,867.

FISCAL IMPACT STATEMENT:

There is no fiscal impact to the Department's General Fund because the source of funding is State Proposition 12 Per Capita.
