17 Questions between husband and wife as to property to be decided in a summary way.

In any question between husband and wife as to the title to or possession of property, either party, . . . ^{F1}, may apply by summons or otherwise [^{F2}in a summary way [^{F3}to the High Court or [^{F4}the family court] and the court][^{F2}in a summary way to the High Court or a county court and the court] may, on such an application (which may be heard in private), make such order with respect to the property as it thinks fit.

In this section “prescribed” means prescribed by rules of court ^{F5}... ^{F6}...
