FROM THE PRESIDENT'S DESK

As I reflect on the past 25 years serving as the President of Lindsey Wilson College, I am filled with a deep sense of gratitude. In my inaugural speech on July 1, 1998, I spoke about the essence of education – that it is not merely about information but about transformation, about changing lives. A quarter-century later, I am humbled by the collective achievements we have made together and the transformative impact LWC has had on countless lives.

It has been a great privilege to work alongside our dedicated faculty and staff, and supportive Board of Trustees. Together, we have fostered a culture of entrepreneurship and continuous improvement. The College stands today as a testament to the hard work and dedication of our mission-driven LWC family. We have reached new heights with our highest enrollment in our 120-year history, boasting 3,925 students – a 27% increase over our previous high. More significantly, we graduated more than 900 students this calendar year, another remarkable tribute to our outstanding faculty and students.

In this issue of the *President's Annual Report*, we take a look at some of the milestones that we have achieved. Milestone such as:

- Our recent 10-year reaffirmation visit for re-accreditation by the Southern Association of Colleges and Schools Commission on Colleges. The College was reaffirmed without a single recommendation, a rarity in higher education. That achievement speaks volumes about our academic quality and our commitment to the LWC mission.
- We have strategically advanced our academic reputation and added programming that responds to our students' needs.
- Our athletic programs continue to achieve at a high level of success as Blue Raider athletics is considered to be one of the best small-college programs in the nation.
- The selfless contributions of our donors, such as the late Henry Baughman, whose \$1.3 million estate gift is the largest in the College's 120-year history.

The most visible change in the last 25 years is the physical transformation of our campus. From 1998-2023, the campus has expanded from 24 to 64 buildings and grown by more than 200 acres.

As I attempt to bring my reflections to a close, I am struck by two thoughts.

First, amid all our achievements – in enrollment, gift income, cash flow, accreditation and graduation rates – we are still a developing institution. There is still much work to be done. I am excited to share that there is so much more still to accomplish, but we cannot achieve our dreams without your continued support. I need each and every one of you to be fully engaged and committed.

Second, let us not lose sight of our mission. Lindsey Wilson is not about the numbers; rather, it's about the one. It's about the individual student who walks into your office or you meet on the sidewalk. Our work, our purpose, and our calling are not about breaking records; it's about transforming lives – whether on our campus in Columbia or at one of our 12 extended campuses across four states. It's about the one.

And I would be remiss if I didn't mention my loving wife, Elise Hendrickson Luckey. Together, we raised three beautiful daughters on this campus, and now our six grandchildren understand why LWC is a special place. Elise, I express my gratitude for accompanying me on this journey, standing by my side, and sharing in the love for our students as deeply as I do.

Being president of Lindsey Wilson College has been and continues to be the world's greatest job. I am eternally grateful.

Largest-ever estate gift

Few people had a bigger impact on the sport of tennis in Kentucky than the late **Dr. Henry Baughman**.

Baughman, who died in 2021 at the age of 82, was also a legendary emergency medical technologist and training pioneer – and he was one of the biggest fans of Lindsey Wilson College tennis.

That's why he left a \$1.3 million gift in his estate – the largest in the College's history – to help build an indoor tennis center.

Baughman became acquainted with LWC through his wife, Southcentral Kentucky native and retired Louisville radiologist Dr. Jann Aaron.

"I met Henry about 18 years ago during a visit with Dr. Aaron," said LWC Vice President of Development Kevin Thompson. "Over time, our relationship grew into a friendship and he began to make frequent visits to the campus. He became close to our student-athletes, especially those in the tennis program."

In 2010, Baughman made the lead gift that allowed LWC to build the Dr. Henry Baughman Tennis Complex, a \$425,000 improvement to the College's tennis courts with seating and lights for nighttime practices and tennis matches.

Baughman, who was born and raised in Lincoln County, Kentucky, said he made the gift to the tennis program because of a lifelong love for the sport and because he believes in the Lindsey Wilson mission to prepare people academically and physically to be productive citizens.

"Tennis is a sport that can be played throughout one's lifetime, as it only takes one other person to have a game, and it provides exercise benefits as well as stimulating the mind to do well in academic studies or in after-college work," Baughman said in 2010. "I also have a great deal of respect for the Lindsey Wilson mission, with its emphasis of serving "every student, every day.”"

Baughman grew up watching his father play tennis. He was an active tennis player for more than 60 years, and his tennis achievements were legendary. There were no tennis courts in his hometown of Stanford until his father built an asphalt court in 1952, Baughman's sophomore year at Stanford High School.

Baughman was ranked No. 1 in Kentucky more than 60 times, and 15 times he has been ranked No. 1 in the nine-state United States Tennis Association Southern, the largest association in the United States. He also earned a No. 4 national ranking in 70 and over singles.

A retired Western Kentucky University professor, Baughman wrote Kentucky's first emergency medical technician training workbook, which has helped save countless lives of accident victims throughout the commonwealth. While at WKU, Baughman's health and safety department broke new ground with a six-hour EMT class.

Baughman was also a member of the LWC Athletic Hall of Fame. He founded the Baughman Visiting Fellows Program which annually invites a scholar in the field of health, safety and wellness to give a public talk and meet with LWC students. He received an honorary doctorate from LWC in 2016.

Meet Student-Athletes **Anatoliy and Anastasiia**

Anastasiia Ivanchenko made her way from Chernivtsi, Ukraine, to Columbia just in time for the start of the 2022 spring semester – and just in time to escape being near Europe’s first major conflict since the end of World War II.

Ivanchenko’s introduction to LWC came through a friend on the Blue Raider swimming team.

“I was looking for the best school for me so I could play tennis,” said Ivanchenko. “My friend, Karolina Bidnik from Warsaw, Poland, was already swimming here and recommended I look at LWC.”

As a member of the LWC tennis team, Ivanchenko was already grappling with adjusting to college life in a new country and learning how to navigate U.S. culture when her anxieties escalated on Feb. 24, 2022 – the day Russian military forces invaded Ukraine.

“I remember the first day after the Russian attacks on Kyiv began, everyone was asking me about my family and I appreciated it but it was so hard to talk about at the time,” she said.

Although Ivanchenko’s home city in southwestern Ukraine is hundreds of miles away from where the war erupted, the initial uncertainty of the situation and the difficulty of communicating with her family made life considerably more difficult.

“The seven-hour time difference made communication difficult,” says

Ivanchenko. “When I am full of energy and ready to talk about my day and catch up they are already asleep for the night.”

Now, nearly two years later, Ivanchenko’s concerns for her homeland have not abated, but she is grateful that at least most of her family members are safe in another country.

“My family has moved to Canada,” Ivanchenko said. “My father has stayed in Ukraine because he cannot leave yet. But my sister and mom are safe and happy, and everything is much better for us. Hopefully, my father can leave soon as well.”

Anatoliy Voloshyn is from Cherkasy, a city in the central part of Ukraine and just 120 miles south of Kyiv. Cherkasy has been attacked by multiple missile strikes.

“My parents have moved to the west of Ukraine, where it is safer, and my brother is with them,” said Voloshyn. “I have relatives in Kyiv, where most of the bombing was taking place. Most of them have either moved to other parts of Ukraine or out of the country to Poland. However, in the beginning, they were hiding in basements for safety. What impressed me the most was their optimism. They have managed to keep a heroic spirit.”

Because of the war, Voloshyn – who is a political science and business administration junior and member of the men’s tennis team – has spent the last two sum-

mers working at the John McEnroe Tennis Academy in New York City.

“I was eventually able to get a work permit because of new U.S. regulations for Ukraine citizens,” Voloshyn said. “That helped me to get a job in New York for the last two years.

“I appreciate the John McEnroe organization and what they have done for us. Through two significant fundraisers for Ukraine, I’ve been able to financially assist my parents and friends who are serving in the military. Being able to contribute financially makes me feel like a more valuable participant in the war effort.”

Voloshyn and Ivanchenko are also very grateful to the LWC community, and President William T. Luckey Jr. for his attentiveness and generosity during this harrowing time.

“I never expected for people to care for someone from a different country like they have,” said Voloshyn. “I can see it around the world, but I can especially see it here on this campus. Everyone really wants to help and offers to pray with us. It means a lot.”

After the war broke out, Voloshyn and Ivanchenko received full scholarships from the College.

“President Luckey called us into his office soon after the war began and he gave us a full scholarship due to the circumstances,” Voloshyn said. “We were all so appreciative.”

Ivanchenko has found summer work at the Flow Tennis Academy in West Hampton, New York. But for now, she is looking forward to the start of the spring semester, when her tennis season will begin.

“I’m really excited to play again and get ready for the next season,” she said.

As for Voloshyn, he plans to spend winter break with his sister in Toronto and prepare for the upcoming spring tennis season. But Ukraine and the war in the Middle East are never far from his mind.

“I don’t feel good being so far away from home and from the people that I know,” Voloshyn said. “But I cannot complain compared to the people who are right there struggling every single day. I just don’t have the right to say that I am feeling badly when my situation is so good.”

Noteable and Noteworthy

LWC Receives Accreditation Reaffirmation from SACSCOC with No Recommendations

Lindsey Wilson College accomplished something that is exceedingly rare in higher education – a perfect checkup.

On Dec. 6, the College was informed by the Southern Association of Colleges and Schools Commission on Colleges – also known as SACSCOC – that it had reaffirmed accreditation for Lindsey Wilson for the next decade. LWC's reaffirmation came without a single recommendation for improvement.

"SACSCOC has a reputation for being the most stringent regional accreditor in the United States," LWC President William T. Luckey Jr. said. "The fact that the visiting team finished its visit without a single recommendation speaks volumes about the quality of our faculty and the work they do with our students. Congratulations to all who assisted in amassing the evidence necessary for a successful visit."

SACSCOC is the body for the accreditation of degree-granting higher education institutions in the Southern states. It serves as the common denominator of shared values and practices primarily among the diverse institutions in Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Texas, Virginia and Latin America and certain other international sites approved by the SACSCOC Board of Trustees that award associate, baccalaureate, master's or doctoral degrees.

SACSCOC mandates a comprehensive review to be conducted by a committee of peers every 10 years. The review includes a rigorous site visit, which happened in March. During LWC's evaluation, the committee assessed the College's compliance with accreditation core requirements and standards in the areas of academic programming, campus facilities, financial stability and management. The team also talked with members of the faculty, staff and student body. LWC was last reaffirmed for reaccreditation in 2013.

The on-site team also endorsed the proposed five-year Quality Enhancement Plan – "Stepping Up For Success: A Three-Pronged Approach to Enhancing Student Success." The plan will focus on three strategies to improve student success: implementing success coaches, improving tutoring and enhancing writing consultations.

"I have chaired somewhere in the neighborhood of 35 SACSCOC accreditation visits, including off-site, on-site, special committees and substantive change committees, and I have never experienced a visit with no recommendations," said Luckey. "Our chair for the committee commented that this speaks to 'the highest level of quality and commitment we have to our students.' LWC is a special place, and it's special because of the people who serve our students and our mission each and every day."

Outstanding Financial Year

Lindsey Wilson College performed extremely well in fiscal year 2023 by setting a new enrollment record that drove net tuition, fees, room and board to an all-time high at \$37.4 million and increased by \$7.3 million over last year. Investment performance added \$5.1 million and the Employee Retention Tax Credit added \$5.5 million in revenue for an increase of \$17.7 million compared to fiscal year 2022. Cash and total assets both reached all-time highs at \$15.6 million and at \$115.6 million, respectively.





Endowment Market Value




The endowment increased \$4.2 million in fiscal year 2023 or 34% in the last five years.

Debt




Debt has steadily declined \$5.1 million or 23% in the past five years.


