Dear Mike:

This letter summarizes the Mid-Atlantic Fishery Management Council's recommendations for 2025 black sea bass specifications, as adopted during their August 2024 meeting. These specifications are based on the 2025 acceptable biological catch limit (ABC) recommended by the Council's Scientific and Statistical Committee (SSC). The ABC is derived from stock projections based on the 2024 Black Sea Bass Management Track Stock Assessment model. The SSC concluded that their recommended ABC is based on the best scientific information available according to National Standard guidelines. The Council agreed to use the same methods as prior years for calculating expected dead discards in each sector to derive the commercial quota and recreational harvest limit. The resulting specifications are shown in the table at the end of this letter.

The Council also adopted a 5% in-season commercial closure buffer for 2025, meaning the commercial fishery would close in-season if 105% of the quota is projected to be landed prior to the end of the year. They made no changes to any other commercial management measures. As you know, the approach for 2025 recreational bag, size, and season limits will be discussed by the Council later this year.
