C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 173.16-acre site has been mined for coal, then a portion was utilized as a landfill. There remains open quarry pits, depressional areas, stockpiles of overburden material, access roads, a trolley berm, several buildings, and staging areas. The topography of the project area slopes down from Tomhicken Road south towards Black Creek. Most of the isolated open water areas & wetlands are on capped areas and receive water from upslope, mainly stormwater, but there is no outflow from these depressions, pits and/or wetlands.

The adjacent forested wetland, at the head of the ephemeral stream, also moderates temperature conditions for aquatic plants, fish, and other animals in downstream reaches. Further, the forested wetlands improves the food web richness by inputting allochthonous material such as leaf litter, branches, fruit and twigs that the biotic communities that biotic communities depend on for energy for their activities. The biological connectivity of the wetland results in greater population carrying capacities and the dampening of disruptive cascades. As a result, the wetland, and it's connecting ephemeral stream, have more than a speculative and insubstantial effect on the chemical, biological and/or physical integrity on the downstream TNW (SUSQUEHANNA RIVER).
