### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**All 12 wetlands (Wetlands A-K and X) were reviewed during a site visit on 11/26/2019 with the consultant and representatives for the landowner. The wetlands/site are located on a parcel that had been historically strip mined. The wetlands under review were all located in closed concaved depressional areas that provide very little functions and values. Wetland data collected by the consultant during the initial wetland delineation was verified along with the delineated boundaries. The wetland met all criteria of the definition of a wetland. The wetlands provide low value functions of sediment/toxicant retention and nutrient removal/retention. There is no evidence of surface flow exiting the wetlands. It is assumed that these wetlands have developed based off of previous land disturbance and receiving and holding rain water and over land sheet flow during rain events and settling in these depressional areas. The closest RPW is Sterry Creek which is not influenced from any of the wetlands. There are no RPWs present on the project area/parcel in review. Wetland X is the closest wetland on the parcel to Sterry Creek (apprx. 500 linear feet). The wetland and Sterry Creek are separated by a hill and water from Wetland X cannot physically enter into Sterry Creek. All other wetlands are > 1,750 linear feet away from Sterry Creek and there are no existing flow patterns to Sterry Creek.**
