**bodies. The Corps has determined that 2 isolated wetland systems are present at this site. No evidence of a connection, surface flow or other hydrologic connection to any other jurisdictional waters of the United States was observed during the Corps site review. In the State of Maryland, isolated waters are not Federally regulated because of the Wilson Case. That is 33 CFR 328.(a)(3) has been removed from Corps regulations in the Fourth Circuit. Therefore, the isolated wetlands at this site are not Federally regulated.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
