Summarize overall biological, chemical and physical functions being performed: The wetland is providing for nutrient cycling, flood protection, habitat for wildlife diversity, ground water recharge, and pollutant trapping.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Due to it's size it offeres the ability to trap flood waters and recharge ground water. These wetlands serve as part of the headwaters of Looks Swamp Creek which flows into Trent Hall Creek in the Patuxent River. These headwater systems are an important part of the overall health of the systems due to the ability to regulate flow, trap and filtering pollutants, and providing wildlife diversity. Due to the location, size and connection directly into Looks Swamp Creek this wetland has a significant nexus with the Patuxent River a TNW.
