OWF, PASPGP5-OWG, PASPG5-OWJ, and PASPG5-OWK) are associated with historic strip mine pits from past coal mining activities. These complexes are neither impoundments of jurisdictional waters that have a surface connection to a relatively permanent waterway, or a non-PRW that flows into a TNW. CR-1, CR-2, CR-6, CR-7, OF-7, OF-8 and OF-9 are either the mainstem of Eddy's Creek or a tributary to Eddy's Creek. Eddy's Creek is perennial as it flows through the area of investigation (flowing in a western direction). Downstream of the site, Eddy's Creek flow into a mine void (sub-surface) along Marshwood Road, east of Route 6. Even though the channel still exists downstream, investigation of the remanent channel, several hundred feet downslope of the void, showed that the channel was filled with leaf litter and appeared that the channel no longer carried flow to a TNW. Thus it no longer provides a surface connection to a navigable water and is non-jurisdictional. Wetland PASPG5-K is an isolated feature that is neither adjacent to nor abutting to a TNW, relatively permanent waterway nor non-RPW that flows to a navigable water. Wetlands PASPG5-S and PASPG5-T are either adjacent to (PASPG5-S) or abutting (PASPG5-T) an unnamed tributary to Eddy's Creek. These wetlands are upstream of where Eddy's Creek goes subsurface into the mine void. Thus PASPG5-S and PASPG5-T are non jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
