Explain: **The Corps received an application for a Department of the Army permit to construct a gravel storage lot near 1177 Patuxent Road, Odenton, Anne Arundel County, Maryland. The applicant provided information, including historic aerial imagery, demonstrating that the project area was previously used for sand and gravel mining activities (attachment 1). The Corps reviewed historic aerial imagery, the State of Maryland MERLIN Webpage, USDA NRCS**

Soil Survey, USFWS NWI Map, and the USGS Topographic Maps for the Corps area of review. The Corps conducted a site visit on January 14, 2022, and field evaluated the wetland areas to confirm the review area only includes two emergent wetlands and one forested wetland. The Corps observed the three wetland areas, meeting all three wetland parameters, positioned on the western portion of the Corps area of review. Based on field observations, information submitted by the applicant, and other supporting data listed above, the Corps has determined the three wetlands within the Corps area of review are isolated, not jurisdictional, and not federally regulated. The three wetlands within the Corps area of review have been determined to meet a category of waters generally not considered jurisdictional, as they were created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel. In conclusion, based on the available resource documentation and the Corps field observations during the January 14, 2022, site visit, the Corps has determined the review area includes only non-jurisdictional wetlands.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The Corps received an application for a Department of the Army permit to construct a gravel storage lot near 1177 Patuxent Road, Odenton, Anne Arundel County, Maryland. The applicant provided information, including historic aerial imagery, demonstrating that the project area was previously used for sand and gravel mining activities (attachment 1). The Corps reviewed historic aerial imagery, the State of Maryland MERLIN Webpage, USDA NRCS Soil Survey, USFWS NWI Map, and the USGS Topographic Maps for the Corps area of review. The Corps conducted a site visit on January 14, 2022, and field evaluated the wetland areas to confirm the review area only includes two emergent wetlands and one forested wetland. The Corps observed the three wetland areas, meeting all three wetland parameters, positioned on the western portion of the Corps area of review. Based on field observations, information submitted by the applicant, and other supporting data listed above, the Corps has determined the three wetlands within the Corps area of review are isolated, not jurisdictional, and not federally regulated. The three wetlands within the Corps area of review have been determined to meet a category of waters generally not considered jurisdictional, as they were created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel. In conclusion, based on the available resource documentation and the Corps field observations during the January 14, 2022, site visit, the Corps has determined the review area includes only non-jurisdictional wetlands.
