agricultural field. There is a swale that begins and ends within the 0.1 acre area. Adjacent to this swale is an area dominated by reed canary grass with hydric soils and positive hydrology. It appears that water just sits in that area as there are no drainage patterns beyond the beginning and end of the swale. The wetland is located in a relatively flat area. There is a slight increase in elevation as you go out into the agricultural field. In conclusion, this is an isolated wetland with no surface connection to, nor is it adjacent to, a waterway that flows to a TNW. In addition, the area is an intrastate wetland, with the use, destruction or degradation of determined to not affect interstate commerce.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
