We have identified green turtle nesting beaches on Naval Base Guam, military leased lands on Tinian in CNMI, and Pacific Missile Range Facility in Hawaii. Under the Endangered Species Act, the Services do not designate critical habitat on DoD areas where we conclude that an INRMP provides a benefit to the species. Will you let me know the Navy's POC for the revising and finalizing the INRMPs on these installations? The Service has recommendations for best management practices that may be incorporated in the INRMPs to provide a benefit to nesting and basking green turtles. I would like to work with the POC to incorporate these recommendations in the INRMP.

I am looking for all Integrated Natural Resources Management Plans (INRMPs) on green turtles. Would you help me to "get the word out" by forwarding this email to others who may have knowledge of INRMPs or green turtles in their regions? Thanks! Jenny

The National Marine Fisheries Service the US Fish and Wildlife Service (together, the Services) are discussing potential critical habitat for our proposed green sea turtle distinct population segments. We have not yet identified critical habitat areas, but before we do, we would like to know what Integrated Natural Resources Management Plans (INRMPs) are available for green turtles. Under the Endangered Species Act, we do not designate critical habitat on DoD areas where we conclude that an INRMP provides a benefit to the species:

(B)(i) The Secretary shall not designate as critical habitat any lands or other geographical areas owned or controlled by the Department of Defense, or designated for its use, that are subject to an integrated natural resources management plan prepared under section 101 of the Sikes Act (16 U.S.C. 670a), if the Secretary determines in writing that such plan provides a benefit to the species for which critical habitat is proposed for designation (16 U.S.C. 1533(a)(3)(B)(i)).
