Reference information

The permit will be issued to the legal name of the applicant and must be the legal Oregon name (for example, Acme Products, Inc.) or the legal representative of the company if it operates under an assumed business name (for example, John Smith, dba Acme Products). ** The name must be a legal, active name registered with the Oregon Secretary of State's Corporation Division unless otherwise exempt from regulation.
