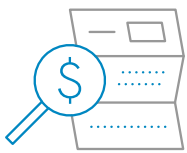

Mark Your Calendars

Each year, shareholders are required by law to report the type and quantity of irrigation water used on land with grandfathered irrigation rights to the Arizona Department of Water Resources (ADWR). Soon, shareholders will receive a summary of their 2024 water use from SRP, including the amount of groundwater and surface water delivered to your land. If you have not received SRP data regarding your 2024 water use by Friday, Feb. 28, please call **(602) 236-5011** or email waterdel@srpnet.com. To file online with ADWR or if you have questions, visit new.azwater.gov. The deadline to file is March 31, 2025.

Irrigation Payments Due



All bills for excess water received in 2024 must be paid by Feb. 21 to avoid an interruption of irrigation service. Any water received beyond the amount shareholders have paid for is considered excess water. 74%

As of Dec. 4, 2024, the SRP reservoir system was **74%** full at **1,509,850** acre-feet in storage. A year ago, the total system was **81%** full. On the Salt River system, we have four reservoirs: Roosevelt, Apache, Canyon and Saguaro lakes. On the Verde River system, we have two reservoirs: Horseshoe and Bartlett.

Fiber Optics and Private Irrigation Systems

In today's interconnected world, fiber optics have become an essential part of our communications infrastructure. These thin strands of glass or plastic transmit light signals over long distances, enabling high-speed data transmission with minimal loss. While fiber optics are primarily associated with telecommunications and internet services, their presence near private irrigation systems can have significant implications.

Ensuring Safety and Coordination

The installation of fiber optics near private irrigation systems requires careful planning and coordination to avoid disruptions. Because private irrigation

systems are not part of Arizona 811, they are not marked before construction. If you become aware of fiber installation near your neighborhood irrigation system, you should contact the contractor doing the work and let them know there is infrastructure in the planned construction area. Work directly with the contractor to come up with a solution that mitigates irrigation disruption. Contact your city planning and permitting department for information related to the fiber installation. Contact an SRP Field Services Liaison if you need help locating the private irrigation system or if you are unsuccessful in locating the contractor.
