Schedule of Membership Benefits and Costs

Individual Membership

Full Member: \$100/year

Associate Member: \$40/year

Student Associate Member: \$20/year

Benefits for Individual Members include:

 - Full Members – Able to vote on all proposed items set before the AASC, including changes to constitution and by-laws.
 - Associate Members – Able to vote for all proposed items, except for changes to the AASC Constitution or By-laws.

SCO/RCC Institutional Membership

Leadership Institutional Member: \$5,000/year

Proposed Amendments to the AASC Constitution

1. Adds a Corporate Membership Class

IV. Membership

1. The Membership of the Association shall consist of:

- a. Full Members
- b. Associate Members
- c. Honorary Members
- d. Student Members
- e. SCO/RCC Institutional Leader Membership
- f. SCO/RCC Institutional Associate Membership
- g. Corporate Membership. Corporate membership is subject to annual approval by a majority vote of the Executive Committee.

The *Membership Schedule* lists costs/benefits of membership for each level, which are set by a 2/3 majority vote of all voting members.

10. Corporate members support AASC vision and mission and also subscribe to the Constitution and By-laws of the Association. They enjoy rights and benefits of membership as outlined in the *Membership Schedule*, but do not have the right to vote on matters of the AASC. Corporate members are welcome and encouraged to participate in all activities and meetings of the AASC.

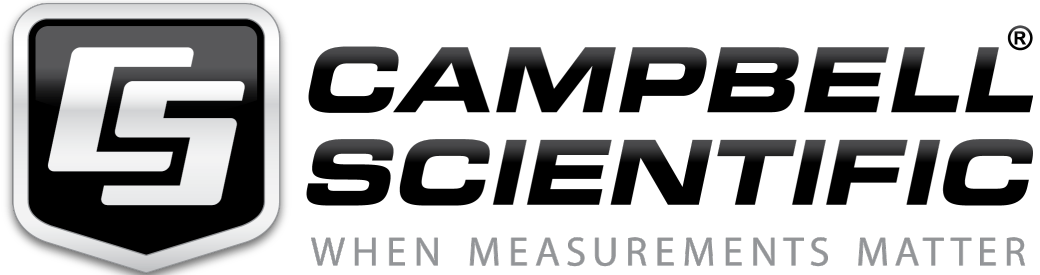
c. Associate Member-at-Large. To directly represent the interests of Associate Members on the Executive Committee, an Associate Member-at-Large will serve as an ex-officio member of the Executive Committee. The Associate Member-at-Large will be eligible for re-election by all Voting Members of the AASC every even year for a two-year term to begin immediately after the annual meeting. The President shall appoint an Associate Member to fill any vacancy that may arise in the office of the Associate-at-Large for the remainder of the unexpired term.
