### Highlights:

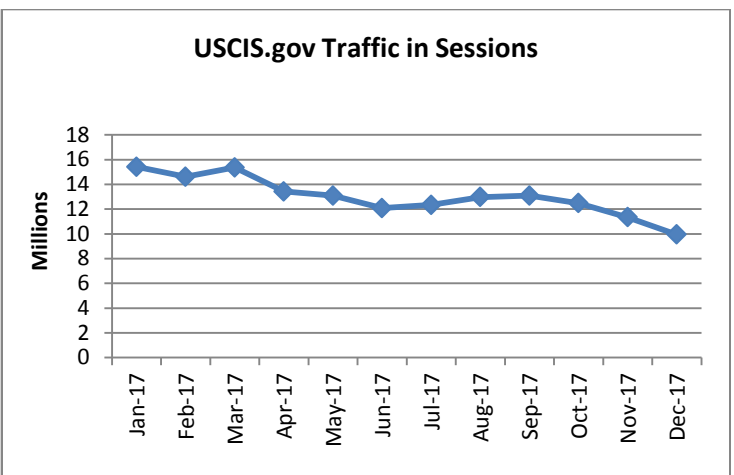
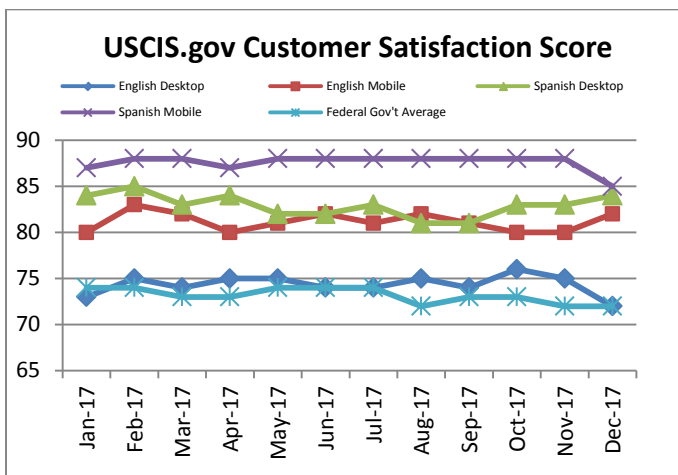
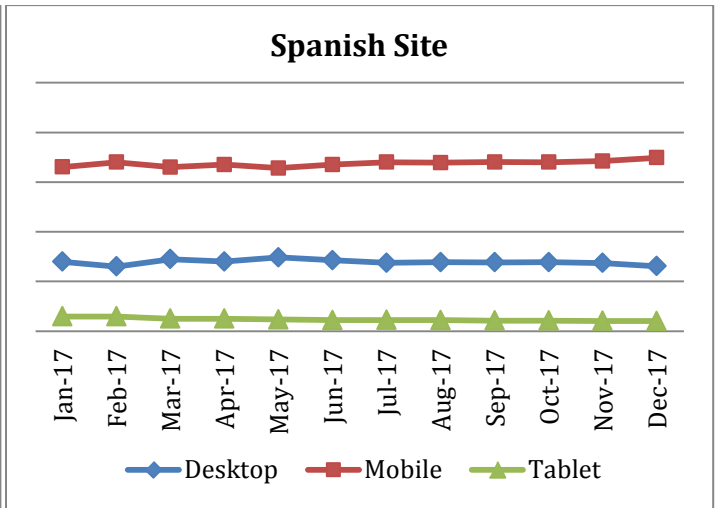
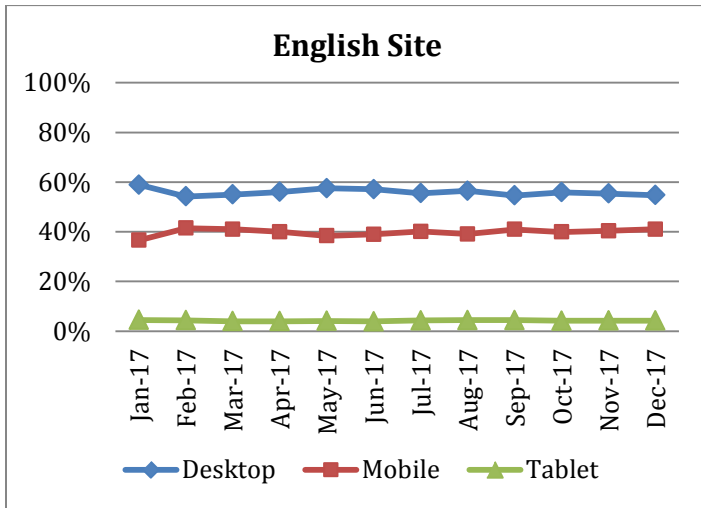
- **Web Traffic Down:** Overall web traffic declined to just under 10 million, due at least in part to a normal seasonal decline in traffic over the holidays.
- **Anti-Fraud Posts Strong on Social Media:** Posts on efforts to combat fraud were among our strongest performers on both [Twitter](#) and [Facebook](#). In fact, all 5 of our top tweets this month had to do with either anti-fraud efforts, or efforts to [protect American workers](#).
- **Top Tweet on Protecting American Workers:** [Our top tweet](#) this month focused on protecting American workers, and garnered over 90,000 impressions (the average tweet receives around 4,000), well above even the [second strongest tweet](#) – which 38,700 impressions – and also focused on protecting Americans.
