RE: Idaho Transportation 19-ALTA Roster through December 31, 2023

Recently, the Idaho Transportation Department (ITD) reviewed all nine (9) companies that responded to a Request for Statement of Qualifications. Based on the criteria detailed in the request, ITD has determined that all nine (9) of the companies that submitted are responsive and qualified and all nine (9) of the companies are on the Idaho Transportation 19-ALTA Roster for Facility Construction projects through December 31, 2023.
