- Justification**
By having the increase to 129K, would reduce our amount of trucks from 30 to 15 making mutipule rounds a day. Thus reducing the amount of trucks on this route and the possibility of off track accidents and less wear and tear on the roads.

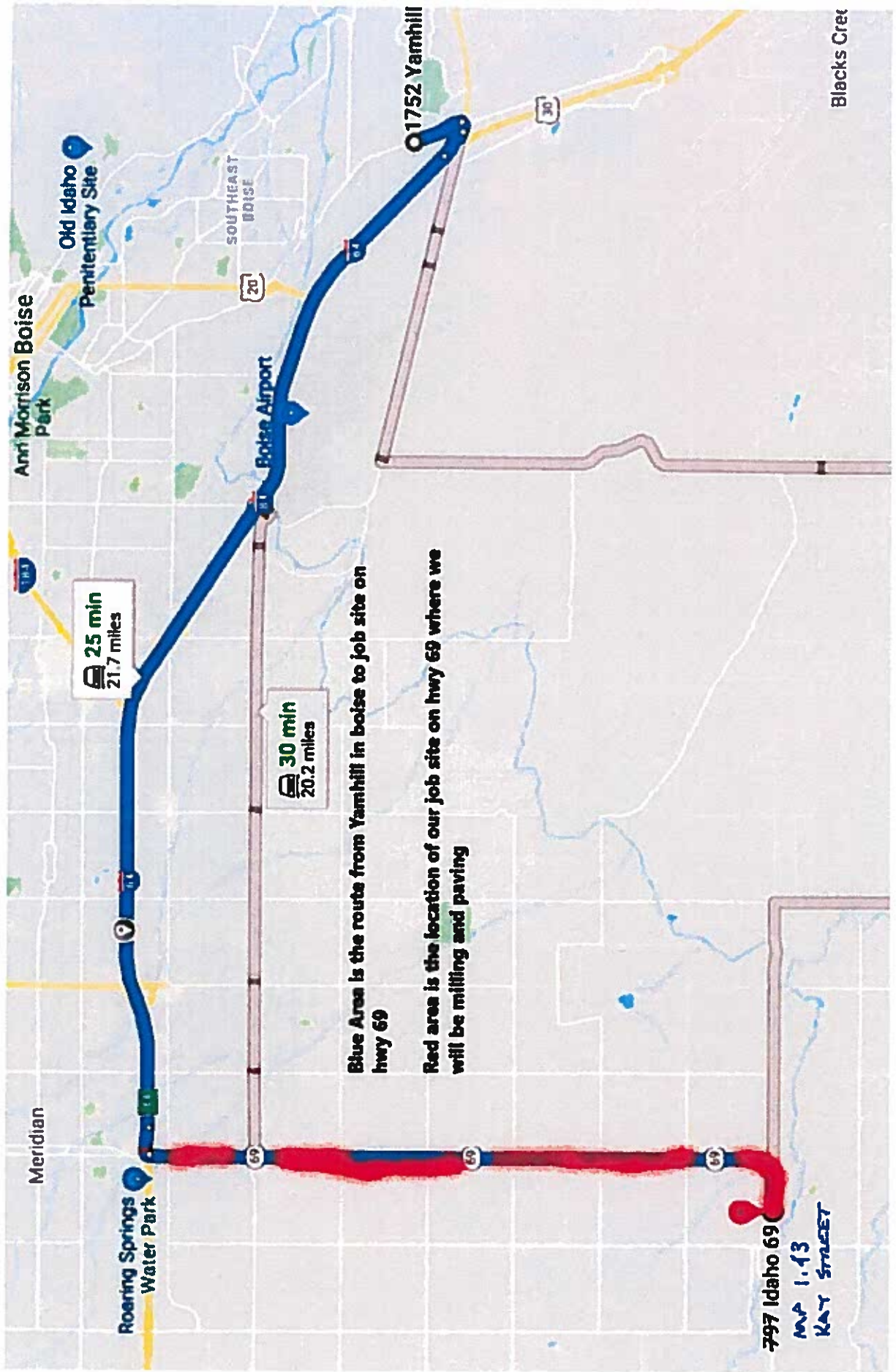
