### Ride TFT – Service Overview



- Point to Point, On-Demand service within city limits
- 6 six-person passenger vans, 2 four-person ADA wheelchair vans
- \$3 standard fare, \$1 discounted fare for riders with disabilities or ages 60+ (LINC cards accepted)
- Children ages 12+ can ride unaccompanied
- Service through Ride TFT app or Dispatch Line, 1-208-974-7433 (extra \$1 fee for dispatch line)











## Important Milestones Since Month 6

- Added Van 8 in mid-April
- Twin Falls Transit Summit at CSI Herrett Center in May
- Various summer promotions and partnerships, including Project Succeed, Beer Fest, Twin Falls Library, and more
- After Hours and airport service still trending upwards; hoping for After Hours "break even" by end of 2024
- City of Twin Falls named direct recipient for 5307 public transportation funds through FTA
- Representation at ITD Statewide Transit Summit and Community Transportation Association of Idaho (CTAI)
- First official site review from ITD upcoming





#### Ridership





### Planning for Growth

**Dropoffs Heat Map** 



- Current program is good, but lacking capacity for ADA riders (over 50% of rides are for disabled or age 60+ passengers)
- Overall average wait times are acceptable, but still high; demand surges and population growth will stress this further
- Future need for some fixed-route service; intercity connection with neighboring communities; additional rolling stock and transit facilities
- Strong public participation plan, council involvement, collaboration with MPO, and budgetary support will be needed to maintain adequate public transit service in Twin Falls
