    - Please note: Due to the high volume of payments AP will have to process, there may be a delay in receiving payment. Please budget for 30 day process time.



# RTAP Program

- Individual Scholarships:
  - Maximum of \$5,000 per scholarship
  - Maximum of two (2) individuals per training, workshop or conferences
  - Maximum of three (3) training, workshop, or conference scholarships per individual per calendar year
  - ITD Hosted trainings do not apply towards the maximums.
  - Webinars, online conferences, and online trainings do not currently apply towards the maximums.

# RTAP Program

- ITD-PT RTAP Scholarship will reimburse the applicant for the following:
  - Training, workshops, conference fees and/or materials
  - Lodging (GSA rate, governmental rate or conference hotel *only-please provide documentation*)
  - Lowest cost of travel, whether airfare or mileage (must include map documentation of mileage being requested)
  - Airline & Baggage Fees
  - Meals only when requested as part of scholarship
  - Parking, Taxi and/or Shuttle fees
  - Rental Car upon request *\*\*\*ITD-PT encourages use of public transportation*
- ITD-PT RTAP Scholarship will not reimburse the applicant for the following:
  - Travel insurance
  - Entertainment costs
  - Costs not originally accounted for in the scholarship application

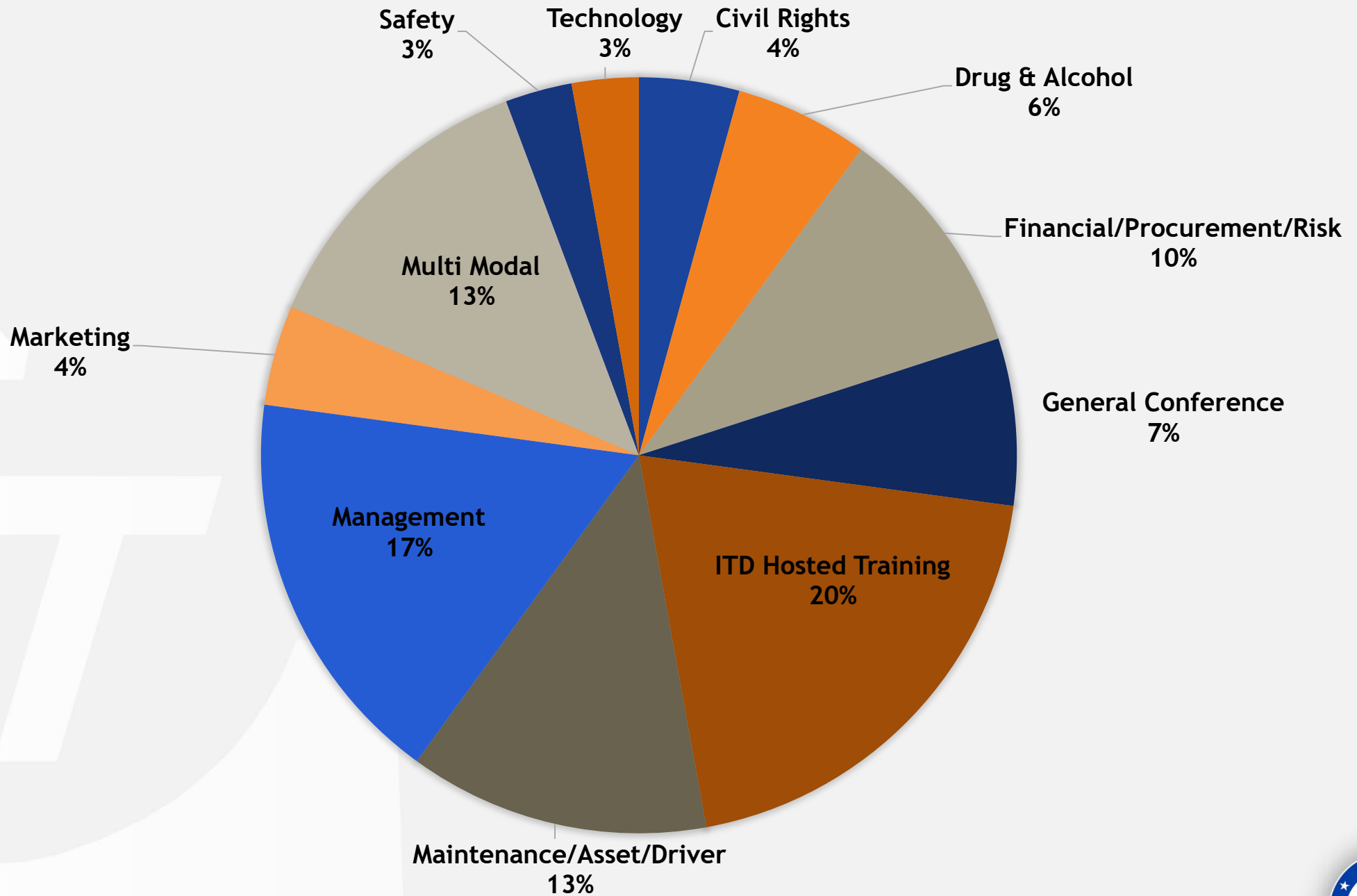

# New DBE Rules Making Changes

- The new rule making changes take effect on May 9<sup>th</sup>, 2024
- All rules and changes can be found at <https://www.transportation.gov/DBEFinalRule>
  - They have summary documents and webinars available
- These changes will affect all DOT funded programs, i.e., FTA, FAA, FHWA
- The rule making change added clear FTA Tier I and FTA Tier II definitions.
- DBE Certification standards have changed some affecting PNW, Interstate Applications, NCA now DOE, etc.



# FTA Tier I and FTA Tier II

- “The final rule includes definitions for FTA Tier I and FTA Tier II recipients. Further, the final rule adds paragraphs to § 26.21(a)(2) to list the applicable requirements for Tier II recipients more clearly. The Department notes that under the new requirement, all FTA recipients that receive planning, capital, or operating assistance and award FTA funded contracts must have a DBE program.”
- “The Department does not anticipate any reduction in awards to DBEs by Tier II recipients under the new rules, especially in light of increased funds being awarded by FTA to transit agencies. Further, FTA will be conducting more oversight of recipients currently awarding \$250,000 or less.”



# FTA Tier I and FTA Tier II (cont.)

- “FTA will remain responsible for ensuring that all FTA recipients subject to the DBE program are awarding and administering their contracts in a nondiscriminatory manner, and the reporting requirements under the new rules will provide FTA the information needed to ensure compliance.”



# FTA Tier I and FTA Tier II (cont.)



- “As a matter of clarification, whether a recipient is tier I or II is determined by the value of contracts it awards, not the value of funds it receives from FTA.”
- “The Department expects recipients to budget and plan accordingly, and if a large grant is awarded then appropriate and commensurate resources should be devoted to compliance.”

# DBE Certification Changes

- The owners PNW (personal net worth) has been changed and moved to \$2.047 million
  - Retirement is now excluded from PNW calculations
  - Leased cars for owners excluded from PNW
- Created a new definition of Distributor, i.e. drop-shipped goods
  - 40% of the contract credit for a distributor can count towards DBE credit.



# DBE Certification Changes (cont.)



- “Applicants have to submit a personal narrative detailing the experiences that demonstrate the social and economic disadvantages they have had to contend with. While applicants bear the burden of both production and persuasion with respect to all elements of certification, certifiers must holistically evaluate all presented evidence before making a determination.”

# DBE Certification Changes (cont.)

- The on-site reviews will have more in-depth questions for pending firms to clearly understand control
  - “It comes down to whether the SEDO in fact—not just in theory or on paper—runs the show. The SEDO must show that they possess not only the authority to make decisions, but in fact make those decisions.”
- On-sites will now all need to be recorded for when/if a firm wants to appeal to the USDOT any denial of certification.
- If simple things are needed to cure an application, the UCP must give the firm a chance to fix or provide information needed.
  - The UCP must set realistic deadlines for the firms to cure their application

# DBE Certification Changes (cont.)

- The firm will have one application in their JOC (jurisdiction of original certification) where they are initially certified.
- The Firm can then apply to multiple states after certified by sending a cover letter with all states applying for with a signed DOE (Declaration of Eligibility). The states applying for then have 10 days to accept the firm into the program.
  - Those additional states then have 30 days to request applications from the JOC if they'd like to further review what was approved.



# DBE Certification Changes (cont.)

- If the firm is to be decertified and they are certified in multiple states, those states will all come together to make a case to either keep them in the program or remove them.
  - They are either still certified in all of the states or in none of the states. It is a complete multiple state decision.



# DBE Certification Changes (cont.)

- UCP firms have 90 days to process a firm's application
  - They can apply for one 30-day extension for the application to process
- Firms have 45 days to appeal a decision to USDOT
- Firms have the opportunity to reapply sometime within a 12-month period, whatever is determined by the UCP





# DBE Certification Changes (cont.)

- All firms have to submit a signed DOE each year, formally the NCA (no change affidavit) to remain certified
  - “We have noted that, with respect to firms that fails to file a timely DOE and documentation of gross receipts, the summary suspension process of § 26.88(b)(2)(ii) enables more rapid action than the decertification procedures of § 26.87. The final rule provides failure to file a timely DOE as an optional ground for summary suspension.”
- All firms that are certified in multiple states will have the same date to submit their DOE
  - USDOT will help to make the changes go into affect for already certified firms across the US



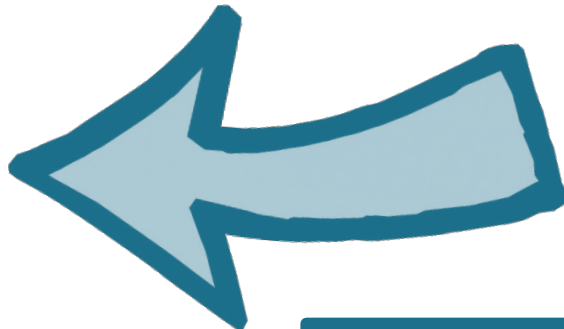
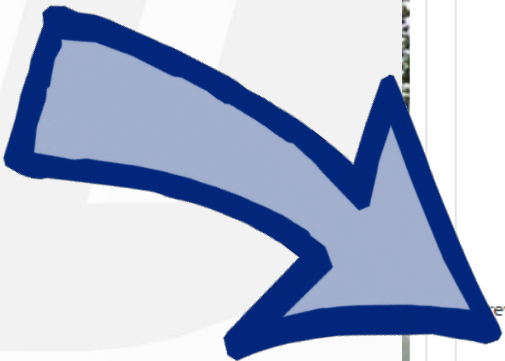
